THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Description of the land to be acquired:

Four (04) allotments of land in total extent of about 0.1364 Hectare, depicted in Advance Tracing No. GA/BLP/06/1464 of 09th March, 2007, prepared by the Surveyor-General, situated in the village of Wandaduwa in the Divisional Secretary's Division of Balapitiya in Galle District in Southern Province and bounded as follows:

01. **Lot 'A' – Nawaratnagodabadda – Extent: 0.0284 Hectare**
North: Road and Nawaratnagodabadda; East: Nawaratnagodabadda; South: Nawaratnagodabadda and Lot B of the same tracing; West: Lot B of the same tracing and road.
