Notice I

NOTICE is hereby given to the following :-

(1) In terms of Section 21(1) of the Cosmetics, Devices and Drugs Act, No. 27 of 1980 and section 2 of the Cosmetics, Devices and Drugs (Amendment) Act, No. 12 of 1993, I, Nimal Siripala De Silva, Minister of Healthcare and Nutrition hereby approve the following categories of Officers as Authorized Officers with effect from 26th day of May, 1998 for the purposes of the said Act.

In case of new recruits the date of appointment of the officer concerned shall be considered as the date of approval of each officer for the purpose of authorized officers.

01. Regional Directors of Health Services of the Department of Health,
02. Medical Officers of Health of the Department of Health,
03. Food and Drugs Inspectors of the Department of Health,
04. Divisional Pharmacists of the Department of Health,
05. Public Health Inspectors of the Department of Health.

(2) I further approve the Director Medical Technology and Supplies by office to issue the Identity cards for each such authorized officers for the purpose of delegation of powers under sub-section 3 of Section 20 of the said Act.
