#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

The land lots within the under mentioned boundaries, having an area of 0.1138 Hectare and shown as Lots 'A', 'B', 'C', 'D', and 'E' in the Plan No. KU/KPW/2007/237 and prepared by the Surveyor-General, situated in the village of Kuliypitiya (F.V.P. 978) in the Minor Division of South Yatikaha Korale within boundary of Kuliypitiya Urban Council Madampe Road 2nd, Divisional Secretary's Division of in Kuliypitiya (West) in the Kurunegala District in the North Western Province.
