#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Tennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for the Construction of Access Road to Rajapihilla Distribution Reservoir and Laying of the Greater Kandy Water Supply Project and will be acquired under the provisions of that Act.
