Regulations

These Regulations may be cited as Motor Traffic Fees (Amendment) Regulations, 2010 and shall come into operation on 19.07.2010 as may be published in the *Gazette*.

Fees of the following items set out under the section (a), (c), (e) and (f) in the *Gazette Notification* No. 1528/22 of 11.02.2008 have been revised as follows :-
