Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

The land containing in an extent about 0.1171 Hectare that was marked Lot Nos. 1, 2, 3 4, 5 and 6 by the Surveyor General, Matara District as depicted in the Tracing No. MT/WLG/2001/155, dated 16.07.2001 and situated in the village of Division No. 1, Kapparithota which belongs to the Urban Council area of Weligama coming within the area of Authority of Weligama Divisional Secretariat in the District of Matara and bounded as follows:

01. Lot No. 1 – Extent about: 0.0063 Hectare

North: Galle Road; East: Galle Road, the rest of the land and Lot No. 2; South: Lot No. 2 and Galle Road; West: Galle Road.

02. Lot No. 2 – Assmt. No. Not known Galle Road, Thanigahawatta – Extent about: 0.0503 Hectare

North: Galle Road, rest of the land and Lot No. 4; East: Lot No. 4, rest of the land, Ekala canal and Lot No. 3; South: Lot No. 3 and Ekala canal; West: Ekala canal, Galle Road and Lot No. 1.

03. Lot No. 3 – Ekala canal – Extent about: 0.0358 Hectare

North: Lot No. 2; East: Lot No. 2, rest of the land, Ekala canal; South: Ekala canal; West: Ekala canal and Lot No. 2.

04. Lot No. 4 – Assmt. No. Not known, Galle Road, Thanigahawatta – Extent about: 0.0134 Hectare

North: Lot No. 2, rest of the land and Lot No. 5; East: Lot No. 5; South: Lot No. 5, rest of the land and Lot No. 2; West: Lot No. 2.

05. Lot No. 5 – Assmt. No. Not known, Galle Road, Thanigahawatta – Extent about: 0.0084 Hectare

North: Lot No. 4 and rest of the land; East: Rest of the Land; South: Rest of the Land, Ekala canal and Lot No. 6; West: Rest of the Land and Lot No. 4.

06. Lot No. 6 – Ekala canal – Extent about: 0.0029 Hectare

North: Ekala canal, rest of the Land and Lot No. 5; East: Rest of the Land and Ekala canal; South: Ekala canal; West: Ekala canal.
