Land Acquisition Notices

THE LAND ACQUISITION ACT, (CHAPTER 460)

Declaration under Clause 05

I, the Minister of Lands and Lands Development hereby declare that the land described below is required for a public purpose and will be acquired under the provisions of the sub clause (1) of the clause No. 05 of the Land Acquisition Act.

Eight blocks of land as described by the following names, extents and boundaries having an extent of about 0.2607 hectares of the total area being the blocks bearing letters from A to H of the advanced tracing prepared by the Survey General dated 29.07.2010 No. Gam/Biya/2010/61 in Heiyantuduwa village of the Adikaripattu Minor Division of Biyagama Divisional Secretariat in Gampaha District.

1. The block bearing letter A — Kosgahahenawatte — Extent about 0.0694 Hectares.

North : Heiyantuduwa Road, Samadhi Mawatha and the remaining portion of this land;
East : The remaining portion of this land ;
South : The remaining portion of this land, Gunasekera Mawatha, the block B of this survey and Heiyantuduwa Road ;
West : Heiyantuduwa Road.

2. The block bearing letter B — Extent 0.0074 Hectares.

North : Heiyantuduwa Road, the block A of this Survey Plan, and Kosgahahenawatte of which the ownership is claimed by J. Abeysiri Gunawardana and A. A. K. Abey Gunawardana ;
East : Kosgahahena of which the ownership is claimed by J. Abeysirigunawardana and A. A. K. Abeygunawardana, Gunasekara Mawatha, Kosgahahenawatte of which the ownership is claimed by Sarath Kalansooriya ;
South : Kosgahahenawatte of which the ownership is of claimed by Sarath Kalansooriya, the block C of this survey plan and Heiyantuduwa Road ;
West : Heiyantuduwa Road.

3. The block bearing letter C — Kosgahahenawatte Extent about 0.0240 Hectares.

North : Heiyantuduwa Road, the block B of this survey Plan, Gunasekara Mawatha, and the remaining portion of this land ;
East : The remaining portion of this land ;
South : The remaining portion of this land, Abeysekara block D of this survey plan and Heiyantuduwa Road ;
West : Heiyantuduwa Road.

4. The block bearing letter D — Extent about 0.0035 Hectares.

- North* : The block C of this survey Plan ;
East : The block C of this survey plan, Kosgahahena of which the ownership is claimed by Sarath Kalansooriya, Abeysekara Road, Kosgahahenawatte of which the ownership is claimed by E. G. Jayantha and the block E of this survey plan ;
South : The block E of this survey Plan ;
West : The block E of this survey plan, Heiyantuduwa Road and block C of this survey plan.

5. The block bearing letter E — Kosgahahenawatte Extent about 0.0116 Hectares.

- North* : The Heiyantuduwa Road the block D of this survey plan, Abeysekara Road and the remaining portion of this land ;
East : The remaining portion of this land ;
South : The remaining portion of this land and Heiyantuduwa Road;
West : Heiyantuduwa Road.

6. The block bearing letter F — Pelangahalanda – Extent about 0.0687 Hectares.

- North* : The remaining portion of this land, in original plan Gam 3687 block Nos. 184, 132 Mahawatte Road and the remaining portion of this land;
East : The remaining portion of this land ;
South : The remaining portion of this land, Mahawatte Road, the block A of this survey plan, Mahawatte Road and the remaining portion of this land ;
West : The remaining portion of this land.

7. The block bearing letter G — Extent about 0.0071 Hectares.

- North* : The block F 4 this survey plan;
East : The block F this survey plan, Pelangaha landa of which the ownership is claimed by E. A. G. Nilmini Mahawatte Road, Pelangaha landa of which the ownership is claimed by D. A. G. Senevirathne and block H of this survey plan ;
South : The block H of this survey plan.
West : The block H of this survey plan, Pelangahalanda of which the ownership is claimed by D. A. G. Senevirathne, Mahawatte Road, Pelangahalanda of which the ownership is claimed by E. A. G. Nilmini and block F of this survey plan ;

8. The block bearing letter H - Pelangahalanda Extent about 0.0690 Hectares.

- North* : The remaining portion of this land, Mahawatta Road the block A of this land and Mahawatte Road;
East : Mahawatte Road and the remaining portion of this land ;
South : The remaining portion of this land, Mabima Road, and the remaining portion of this land.
