#### FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE ANURADHAPURA MUNICIPAL COUNCIL UNDER SECTION 65A(2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)
