FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE NIKAWERATIYA PRADESHIYA SABHA UNDER SECTION 65A(2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of a member in Nikaweratiya Pradeshiya Sabha has fallen vacant by reason of being ceased to be a member of the party ;

And whereas the Secretary of the United People's Freedom Alliance, the recognized political party to which Tennakoon Mudiyansele Herath Banda Tennakoon, the member belonged, was required by me under Section 65A(2) of the aforesaid Ordinance, to nominate a person eligible under the Ordinance for Election as a member of that Nikaweratiya Pradeshiya Sabha who belongs to such party who shall be declared elected as a member within a period of thirty (30) days;
