THE JUDICATURE ACT, No. 2 of 1978

REGULATION made by the Minister of Justice with the concurrence of the Chief Justice, under section 61 of the Judicature Act, No. 2 of 1978 read with section 60 of the aforesaid Act.

Regulation

The Regulation made under Section 61 of the Judicature Act, No. 2 of 1978, published in *Gazette Extraordinary*, No. 43/4 of July 2, 1979 as amended from time to time, is hereby further amended in the Schedule to that regulation as follows:—

- (1) by the insertion, immediately after the entries relating to the “Magistrate’s Court of Maligakanda” appearing in Column I and Column II of that Schedule, of the following:—

“The Magistrate Court of Kaduwela All actions, proceedings or matters –

(a) arising under the Children and Young Persons Ordinance (Chapter 23);

and

(b) arising out of, or in relation to, an offence under the Penal Code or any other Law for the time being in force,

against or in relation to a “child” or a “young person” as defined in law within the Judicial Divisions of Colombo, Mount Lavinia, Fort, Maligakanda, Gangodawila, Kaduwela and Moratuwa.”;

- (2) by the omission, of the entries relating to the “Magistrate Court of Mount Lavinia” appearing in Column I and Column II of that Schedule.
