AN ACT TO AMEND THE CODE OF CRIMINAL PROCEDURE ACT, NO. 15 OF 1979

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows :-

1. This Act may be cited as the Code of Criminal Short title. Procedure (Amendment) Act, No. 7 of 2006.

2. The First Schedule to the Code of Criminal Procedure Amendment of the Act, No. 15 of 1979 (hereinafter referred to as the "principal enactment") as last amended by Act, No. 28 of 1998 is hereby amended as follows:—

(1) by the insertion, immediately after the entry relating to section 286A, of the following entries —

(2) by the repeal of the heading, appearing immediately after the entry relating to section 349 and the substitution therefor of the following new heading :—

"KIDNAPPING, ABDUCTION, PROCURATION, SEXUAL EXPLOITATION OF CHILDREN, TRAFFICKING, DEBT BONDAGE, SERFDOM, FORCED OR COMPULSORY LABOUR, SLAVERY, RECRUITMENT OF CHILDREN FOR USE IN ARMED CONFLICT, OFFENCES RELATED TO ADOPTION AND SOLICITING A CHILD."

(3) by the insertion, immediately after the entries relating to section 358 of the following new entries —

"358A Debt Bondage, Serfdom, Forced or Compulso Labour, o Slavery.	•	Same	Same	Same	Imprisonment of either description for a term not exceeding twenty years and fine.

(4) by the repeal of all the entries relating to section 360c and the substitution therefor of the following entries:—

(5) by the repeal of all the entries relating to section 365B and the substitution therefor of the following entries:—
