AN ACT TO INCORPORATE THE FEDERATION OF PHOTOGRAPHIC SOCIETIES OF SRI LANKA

WHEREAS a Federation called and known as the "The Preamble. Federation of Photographic Societies of Sri Lanka" has heretofore been formed in Sri Lanka for the purpose of effectually carrying out its objects and transacting all matters 5 connected with the said Federation according to the rules agreed to by its members:

AND WHEREAS the said Federation has heretofore successfully carried out and transacted the several objects and matters for which it was established, and has applied to 10 be incorporated and it will be expedient to grant the said application:

BE it therefore enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:—

- 1. This Act may be cited as the The Federation of Short title. 15 Photographic Societies of Sri Lanka (Incorporation) Act, No. of 2013.
- 2. From and after the date of commencement of this Incorporation Act, such and so many person as are now members of The of the Federation of Photographic Societies of Sri Lanka (hereinafter Photographic 20 referred to as the "Federation") or shall hereafter be admitted Societies of as members of the Corporation hereby constituted, shall be a body corporate with perpetual succession, under the name and style of The "Federation of Photographic Societies of Sri Lanka" (hereinafter referred to as "the Corporation") and 25 by that name may sue and be sued, with full power and authority to have and use a common seal and to alter the

3. The general objects for which the Federation is General constituted are hereby declared to be-

objects of the Corporation.

- (a) to popularize the art of photography as an artistic and technical media;
- 5 (b) to avail an oppoutunity in order to learn the photographic art theoretically and practically free of charge and to obtain any other professional qualification in the field of photography;
- (c) to facilitate the school students to learn the photographic art free of charge as an aesthetic 10 subject;
 - (d) to take action in order to keep the photographic art alive, and to safeguard the common rights of the members of the societies;
- (e) to publish any useful publication under the 15 sponsorship of the federation with the view of promoting the field;
 - (f) to popularize the same among the photographic societies so established; and
- (g) to develope co-operation among the photographic 20 societies internally and internationally in order to achieve the above objectivies; to educate how to protect environment and to prepare for the future; and to develop co-operation and friendship among the societies. 25
 - 4. (1) The management, control and administration of Management the Corporation shall, subject to the provision of this Act, of the affairs and the rules in force for the time being of the Corporation, of the Corporation. vested in a Board of Directors (hereinafter referred to as the

30 "Board") consisting of the office bearers and such other persons as may be provided for in such rules and elected in accordance therewith.

- (2) The first Board of the Corporation shall consist of the members of the Board of the Federation holding office on the day preceding the date of commencement of this Act.
- 5. Subject to the provision of this Act and any other General written law, the Corporation shall have the power to do, Powers of the perform and execute all such acts, matters and things whatsoever as are necessary or desirable for the furtherance of its objects or any one of them, including the power to open, operate and close bank accounts, to borrow or raise 10 moneys with or without security, to receive or collect grants or donations, to invest its funds, to erect any building or structure on any land held by the Corporation, and to engage, employ and dismiss officers and servants required for the carrying out of the objects of the Corporation.

15 6. (1) It shall be lawful for the Corporation, from time to Rules of the time, at any general meeting and by the votes of not less Corporation. than two thirds of the members present and voting, to make rules, not inconsistence with the provision of this Act or any other written law, for all or any of the following matters:—

- 20 the classification of membership, fees payable by each class of members and admission, withdrawal, expulsion or resignation of members and for the maintaining of register of members;
- (b) the election of office bearers of the Board or 25 vacation of or removal from, office and the powers, duties and functions of the office bearers;
 - (c) the appointment, powers, duties and functions and conditions of the various officers, agents and servants of the Corporation;
- 30 (d) the procedure to be followed at the summoning and holding of meetings of the Board, the Corporation and any sub-committee thereof, including the quorum therefore and the conduct of business thereat;

- (e) the qualifications and disqualifications for members of the Board and the Corporation; and
- (f) the administration and management of the property of the Corporation for the accomplishment of the objects the Corporation.
- (2) The rules made by the Corporation may be amended, altered, added to or rescinded at a like meeting and in like manner as a rule made under subsection (1).
- (3) The members of the Corporation shall at all time be 10 subject to rules of the Corporation made under this section.
- (4) The rules of the Federation in force on the day preceding to date of commencement of this Act, shall in so far as they are not inconsistent with the provisions of this Act or any other written law, be deemed to be rules of the 15 Corporation made under this section.
- 7. (1) The Corporation shall have its own Fund. All Fund of the moneys received by way of gift, bequest, donation, transfer, Corporation. subscription, contribution or fees shall be deposited to the credit of the Corporation in one or more Banks as the Board 20 of Management shall determine.

- (2) There shall be paid out of the Fund of the Corporation, all such sums of money as may be required to defray any expenditure incurred by the Corporation in carrying out the objects of the Corporation.
- 8. The Corporation shall be able and capable in law, Corporation 25 to take and hold any property movable or immovable may hold which may become vested in it by virtue of any purchase movable and grant, gift, testamentary disposition or otherwise, and immovable. all such property shall be held by the Corporation 30 for the purposes of this Act, and subject to the rules in force for the time being of the Corporation with power to sell, mortgage, lease, exchange or otherwise dispose of the same.

9. No member of the Corporation shall, for the purpose Limitation of of discharging the debts and liabilities of the Corporation or liability of for any other purpose, be liable to make any contribution members. exceeding the amount of annual subscription payable by 5 him to the Corporation.

10. If upon the dissolution of the Corporation there Property remains after the satisfaction of all its debts and liabilities, remaining on any property whatsoever, such property shall not be dissolution. distributed among the members of the Corporation but shall 10 be given or transferred to some other institute or institutes having objects similar to those of the Corporation, and which is or are by the rules thereof prohibited from distributing any income or property among its or their members. Such institution or institutions shall be determined by the Board 15 at or immediately before the dissolution of the Corporation.

11. The main objective of the federation is to give due Protecting recognition to the photographers as professionals while the accepting all other aesthetics as professions within Professionalism. Sri Lankan territory. They shall comply to the code of ethics 20 to be followed by the professionals.

12. (1) The financial year of the Corporation shall be the Accounts and calendar year.

Audit.

- (2) The Corporation shall cause proper accounts to be kept of income and expenditure, assets and liabilities and 25 all other transactions of the Corporation.
 - (3) The accounts of the Corporation shall be audited by a qualified auditor as may be determined by the Board.

In this section "qualified auditor" means—

30

(a) an individual who being a member of the Institute of Chartered Accountants of Sri Lanka, or any other Institute established by law, possesses a certificate to practice as an Accountant issued by the Council of such Institute; or

- (b) a firm of Accountants each of the resident partners of which, being a member of the Institute of Chartered Accountants of Sri Lanka or of any other Institute established by law, possesses a certificate to practice as Accountant issued by the Council of such Institute.
- 13. The seal of the Corporation shall not be affixed to Seal of the any instrument whatsoever, except in the presence of such Corporation. number of person as may be duly aithorized by the Board 10 who shall sign their names on the instrument in token of their presence and such signing shall be independent of the signing of any person as a witness.

14. Nothing in this Act contained shall prejudice or Saving of the

- affect the rights of the Republic or any body politic or rights of the 15 corporate or of any other person, except such as are Republic and mentioned in this Act and those claiming by, from or under others. them.
- 15. In the event of any inconsistency between the Sinhala text Sinhala and Tamil texts of this Act, the Sinhala text shall to prevail in 20 prevail.
