STATEMENT OF LEGAL EFFECT

The amendments made to sections $24,27,27_A$, 28, 36, 52 and 61 of the Births and Deaths Registration Act (Chapter 110) by clauses 2,3,4,5,6,7,8, of this Act revises the fees payable and specifies the mode of payment.

AN ACT TO AMEND THE BIRTHS AND DEATHS REGISTRATION ACT (CHAPTER 110)

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:-

9. Any fees charged or collected by or on behalf of the Validation Registrar- General or any person authorised under this Act, and indemnity for any purpose authorized by this Act to charge or collect, from January 1, 2013 and ending on March 31, 2013, shall

5 be deemed to have been validly charged or collected by the Registrar- General or by any such person authorised under this Act:

Provided that the aforesaid provisions of this section shall not affect any decision or order made by any Court or any 10 proceedings pending in any Court in respect of any fee charged or collected during the aforesaid period.

10. In the event of any inconsistency between the Sinhala text Sinhala and tamil text of this Act, the Sinhala text shall prevail. to prevail in case of

inconsistency.
