#### STATEMENT OF LEGAL EFFECT

*Clause 2*: This clause amends section 24 of the Marriage Registration Ordinance (Chapter 112) (hereinafter referred to as the "principal enactment") by specifying the mode of payment of fees to the registrar of the division and the District Registrar.

*Clause 3*: This clause amends section 27 of the principal enactment by revising the amount of fees to be paid to the District Registrar and specifying the mode of payment.

Clause 4 : This clause amends section 34 by specifying the fees to be paid to the Registrar.

*Clause 5* : This clause amends section 38 by revising the amount of fees to be paid and specifies the mode of payment.

*Clause 6* : This clause amends section 51 by requiring the applicant to pay an amount in place of affixing stamps.

*Clause 7*: This clause amends section 62 of the principal enactment by giving the power to the Minister to revise fees enumerated in the second schedule by rules published in the Gazette.

Clause 8 : This clause replaces the second schedule to this Act.

#### AN ACT TO AMEND THE MARRIAGE REGISTRATION ORDINANCE (CHAPTER 112)

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:-

1. This Act may be cited as the Marriage Registration Short title (Amendment) Act, No. of 2013 and shall be deemed to have and date of operation. 5 come into operation from January 1, 2013.

2. Section 24 of the Marriage Registration Ordinance Amendment (Chapter 112) (hereinafter referred to as the "principal enactment") is hereby amended by the repeal of subsection (6) of that section, and the substitution therefor, of the Registration 10 following subsection :----

"(6) Every notice to a Registrar of a Division or to a 112). District Registrar as the case may be, under subsection (1), (2) or (3) of section 23 or every notice under subsection (4) thereof, shall be accompanied by a receipt issued by

- 3. Section 27 of the principal enactment is hereby Amendment 20 amemded by the repeal of subsection (4) of that section and of section 27 the substitution therefor, of the following subsection :-

"(4) Where the declaration is made before the District Registrar, the party making the declaration shall pay rupees one hundred or such amount as may be prescribed by the 25 Minister from time to time and where the declaration is made before the Registrar of a Division it shall be accompanied by a receipt issued by the District Registrar in proof of payment of a sum of rupees one hundred or such amount as may be prescribed.". 30

4. Section 34 of the principal enactment is hereby Amendment amended by the repeal of subsection (5) of that section and of section 34 the substitution therefor, of the following subsection :-

"(5) The minister shall, within seven days from the 5 date of the solemnizing of the marriage, separate from the register book the duplicate statement of the marriage and transmit the same to the District Registrar within whose district the marriage was solemnized together with a fee specified in the second schedule to this Act, as may be

10 prescribed by the Minister from time to time, which is payable to such Registrar for the registration of such marriage.".

5. Section 38 of the principal enactment is hereby Amendment amemded by the repeal of subsection (2) of that section and of section 38 

"(2) In case the female party belongs to a class other than that described in the preceding subsection or is in the opinion of the District Registrar, not entitled to the benefits of that subsection, it shall be lawful for the District

"(2) The applicant shall pay in respect of every written application and in respect of every certified copy or certified extract thereof such amount as may be prescribed by the Minister from time to time.".
