AN ACT TO AMEND THE WELFARE SOCIETY OF THE SCHOOL FOR THE  
MENTALLY SUBNORMAL CHILD (INCORPORATION) ACT, NO. 75 OF  
1988

BE it enacted by the Parliament of the Democratic Socialist  
Republic of Sri Lanka as follows :—

1. This Act may be cited as the Welfare Society of the School for the Mentally Subnormal Child (Incorporation) (Amendment) Act, No. of 2013. Short title.
2. The long title to the Welfare Society of the School for the Mentally Subnormal Child (Incorporation) Act (hereinafter referred to as the “principal enactment”) is hereby repealed and the following long title substituted thereof:— Amendment  
of Long Title  
of the

enactment  
No. 75 of  
1988.
- “An ordinance to Incorporate the Chitra Lane Welfare Society for Children with Special Needs”
3. (1) In the principal enactment and in any other written law there shall be substituted for the words “the Welfare Society of the School for the Mentally Subnormal Child (Incorporation) Act” of the words “the Chitra Lane Welfare Society for Children with Special Needs Ordinance” General  
amendments  
to the  
principal  
enactment.
- (2) Every reference to “the Chitra Lane Welfare Society of the School for the Mentally Subnormal Child (Incorporation) Act” in any regulation, rule, notice, notification, contract, communication, deed, legal document or other document shall be read and construed as a reference respectively to the “Chitra Lane Welfare Society for Children with Special Needs”.
4. Clause 6(3) of the principal enactment is to be amended as follows :— Amendment  
of section 6  
of the  
principal  
enactment.
- “A vacancy in the Board of Trustees of the Corporation occurring upon the death, resignation, incapacity or removal of a Trustee from office, his/her successor

shall be appointed by the remaining Trustees from  
amongst members of the Corporation who have  
completed not less than two years of membership.  
The maximum number of members in the Board of  
5     Trustees shall be ten.”

5.   In the event of any inconsistency between the Sinhala and Tamil texts of this Act, the Sinhala text shall prevail.
