AN ACT TO INCORPORATE THE WAREHOUSE PROJECT

WHEREAS an Association called and known as the “Warehouse Project” has heretofore been formed in Colombo for the purpose of effectually carrying out and transacting the objects and matters connected with the said Association according to the rules agreed to by its members :

Preamble.

AND WHEREAS the said Warehouse Project has heretofore successfully carried out and transacted the several objects and matters for which it was established and has applied to be incorporated and it will be for the public advantage to grant such application :

BE it therefore enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:—

1. This Act may be cited as the Warehouse Project (Incorporation) Act, No. of 2013.

Short title.

2. From and after the date of commencement of this Act, such and so many persons as now are members of the “Warehouse Project” or shall hereafter be admitted as members of the Corporation hereby constituted, shall be a body corporate with perpetual succession, under the name and style of the “Warehouse Project” (hereinafter referred to as “the Corporation”) and by that name may sue, and be sued in all Courts, with full power and authority to have and use a common seal and the alter same at its pleasure.

Incorporation of the Warehouse Project.

3. The general objects for which the Corporation is constituted are hereby declared to be—

General objects of the Corporation.

(a) to provide social services to the less privileged persons in all parts of the country by helping them to meet their basic needs, train and develop individual skills, help find employment and improve their standard of living;

- (b) to provide assistance to low income families in urban and rural communities to meet their basic needs and uplift living standards;
- 5                      (c) to use creative arts as a platform, to help children and youth of all walks of life, and different cultural and religious backgrounds, to meet and interact with each to foster unity;
- 10                      (d) to promote social, spiritual and cultural activities to develop and foster high moral, ethical and social values in society;
- (e) to provide opportunities for youth to learn new skills and receive on the job training and assist them to set up small scale businesses within their communities;
- 15                      (f) to provide an opportunity for people to become aware of needs within their communities, and promote a culture of helping each other and sharing resources or development and growth of their own communities;
- 20                      (g) to organize free health camps, clinics, check-ups, and other community service camps and distribute free medicines to the needy, with the help of volunteer medical professionals, to improve the health and well being of citizens;
- 25                      (h) to provide accounting, financial, legal and other professional support and advise to any community in Sri Lanka, to help them manage their lives in a better way;
- 30                      (i) to establish island-wide information technology centres for the advancement of scientific studies and development of the country;

- (j) to provide assistance to governmental and non governmental organizations for generating employment amongst youth;
- 5 (k) to obtain and provide grants and other forms of assistance for the commencement and advancement of the above mentioned projects;
- 10 (l) to co-ordinate with like minded persons and organizations both local and foreign, and to organize meetings, seminars, conferences etc.for the advancement of the above mentioned projects;
- 15 (m) to promote, arrange and organize exhibitions, lectures, seminars, discussions, workshops and other activities with a view to accomplishing the objectives of the Warehouse Project and to print, publish and distribute such brochures, journals, bulletins and newspapers; and
- (n) to do all such other acts as may be necessary for the carrying out of all or any of the aforesaid objectives.
- 20 **4.** Subject to the other provisions of this Act and any other written law the Corporation shall have the power to do, perform and execute all such acts, matters and things whatsoever, as are necessary of desirable for the promotion of furtherance of the objects of the Corporation or any one of them, including the power to acquire and hold property  
25 movable or immovable, to open, operate and close bank accounts to borrow or raise money with or without security to receive or collect grants, donations, to invest its funds, to erect any building or structures on any land held by the Corporation and to engage, employ, dismiss officers and  
30 servants required for the carrying out of the objects of the Corporation.
- 5.** (1) The affairs of the Corporation shall, subject to other provisions of this Act and the rules in force for the time being of the Corporation, be administered by a Board of  
35 Directors (hereinafter referred to as the “Board”) consisting
- General powers of the Corporation.
- Management of the affairs of the Corporation.

of a Chairman, Vice Chairman, Managing Director, Secretary, Treasurer and a maximum of seven other Directors and elected in accordance with the rules of the Corporation.

5                      (2) The first Board of Directors of the Corporation shall consist of the members of the Board of the Association holding office on the day immediately preceding the date of commencement of this Act. Such Board shall hold office until a Board of Directors is elected in accordance with the rules of the Corporation.

10                    6. (1) It shall be lawful for the Corporation from time to time, at any general meeting and by a majority of votes of not less than two-thirds of the members present to make rules not inconsistent with the provisions of this Act, or any other written law, for all or any of the following matters and  
15                    any other matter in relation to the management of the affairs of the Corporation and accomplishment of its objects:—

Rules of the Corporation.

(a) the classification of members and mebership fees, their admission, withdrawal, or expulsion from membership;

20                    (b) the election of the members to the Board of Directors and their powers and duties;

(c) the election of office bearers, their term of office, resignation from vacation of or removal from office and their powers and duties;

25                    (d) the procedure to be followed in the summoning and holding of meetings of the Council, the quorum therefore and the conduct of business thereat;

(e) the administration and management of the property of the Coporation, including funds.

30                    (2) Any rule made by the Corporation may be altered, added to, amended or resinded at a like meeting and in like manner as a rule made under subsection (1).

(3) The members of the Corporation shall be subject to the rules of the Corporation.

7. (1) The Corporation shall have its own fund and all moneys heretofore or hereafter to be received by way of gifts, bequests, donations, subscription, testamentary dispositions, fees, grants for donations or contributions in cash or kind from local or foreign institutes and individuals, members and non-members.

Fund of the Corporation.

(2) All monies received shall be deposited in the name of the Corporation in one or more banks and be invested in any suitable manner as the Board shall determine.

(3) All expenditure incurred by the Corporation in the exercise, performances and discharge of its powers, duties and functions of the Corporation shall be paid out of the Funds of the Corporation.

8. All debts and liabilities of the Association existing on the day preceding the date of Commencement of this Act, shall be paid by the Corporation hereby constituted and all debts due, subscriptions and contributions payable to the Association on that day shall be paid to the Corporation for the purpose of this Act.

Debts due by and payable to the Fund.

9. No member of the Corporation shall for the purpose of discharging the debts and liabilities of the Corporation or for any other purpose be liable to make any contribution exceeding the amount due from such member as membership fees.

Limitation of liabilities of members.

10. The Corporations shall be able and capable in law to acquire and hold any property, movable or immovable which may become vested in it by virtue to any purchase, grant, gift, testamentary disposition, trust or otherwise and all such property shall be held by the Corporation for the purpose of this Act, and subject to the rules in force for the time being of the Corporation, with full power to sell,

Corporation may hold property movable and immovable.

**11.** The seal of the Corporation shall not be fixed to any instrument whatsoever, except in the presence of such number of persons as may be provided for in the rules in for for the time being of the Corporation, who shall sign their names to instrument in token of their presence, and such signing shall be independent of the signing of any person as witness.

**13.** In the event of any inconsistency between the Sinhala and the Tamil texts of this Act, the Sinhala text shall prevail.
