AN ACT TO PROVIDE FOR THE FILLING OF VACANCIES IN THE OFFICE OF MAYOR, DEPUTY MAYOR OR A MEMBER OF LOCAL AUTHORITIES ELECTED UNDER THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262); AND FOR MATTERS CONNECTED THEREWITH OR INCIDENTAL THERETO.

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:-

1. This Act may be cited as the Local Authorities Filling Short title. of Vacancies (Special Provisions) Act, No. of 2013.

For the purpose of filling of a vacancy in the office of Filling of Mayor, Deputy Mayor or a Member, elected to any local vacancies of authority under the provisions of the Local Authorities Mayor etc. Elections Ordinance (Chapter 262), which were in operation Local on the date immediately preceding the date of coming into Authorities
- 10 operation of the Local Authorities Elections (Amendment) Elections Act, No. 22 of 2012, the provisions of the said Ordinance, Ordinance shall apply to and in relation to the filling of such vacancies, $\frac{(Chap}{262)}$. notwithstanding the repealing or amendment of the relevant provisions by the Act, No. 22 of 2012:

- 15 Provided however that, where a vacancy occurs in the office of Mayor in the circumstances specified in subsection (4) of section 66B, inserted in the said Ordinance by the Act, No. 22 of 2012, then the provisions of that subsection shall apply in relation thereto.
- 20 3. The provisions of this Act shall be in operation for a Duration of period of four years commencing from the date of the Act. commencement of this Act.

4. Any vacancy in the office of Mayor, Deputy Mayor Validation. or Member, filled during the period commencing from 25 January 1, 2013 and ending on the date of commencement of this Act shall be deemed to have been validly filled.

Interpretation.

"Deputy Mayor" means the Deputy Mayor of a Municipal Council or the Vice-Chairman of an Urban Council or a Pradeshiya Sabha; and

"Mayor" means the Mayor of a Municipal Council or the Chairman of an Urban Council or a Pradeshiya Sabha.

6. In the event of any inconsistency between the Sinhala Sinhala text and Tamil texts of this Act, the Sinhala text shall prevail.
