An Act to amend the National Institute of Business

Management Law, No. 23 of 1976

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:—

- **1.** This Act may be cited as the National Institute of Short title. Business Management (Amendment) Act, No. of 2013.
- 5 2. Section 6 of the National Institute of Business Amendment Management Law, No. 23 of 1976 is hereby amended in subsection (1) of that section, by the repeal of the paragraphs (a) and (b) thereof, and the substitution therefor, of the following new paragraphs:—
- 10 "(a) the following ex-officio members, namely _
 - (i) the Director-General of the Institute appointed under section 16;
 - (ii) the President or Vice President of the Federation of Chambers of Commerce and Industry of Sri Lanka;
 - (iii) the President or Vice President of the National Chamber of Commerce of Sri Lanka;
 - (iv) the Director of the Postgraduate Institute of Management established under the Universities Act, No. 16 of 1978;
 - (v) Secretary to the Ministry of the Minister in charge of the subject of Technical and Vocational Education and Training or Senior Officer nominated by the Secretary;
- 25 (vi) a Senior Officer of Central Bank of Sri Lanka nominated by the Governor of such Bank;

 - (vii) Secretary to the Ministry of the Minister in charge of the subject of Finance and Planing or Senior Officer nominated by the Secretary; and
- 5 (viii) the Chief Executive Officer of the Institute of Information and Communication Technology Agency of Sri Lanka established under the Information and Communication Technology Act, No. 27 of 2003 or Senior 10 Officer nominated by such Chief Executive Officer.
 - (b) the following members to be appointed by the Minister-
- (i) two members being persons with a minimum 15 of ten years experience in Business Management and have achieved distinction in the area of management; and
- (ii) one member being a person with a minimum of ten years experience in industrial relations 20 and trade union activities.".
 - 3. In the event of any inconsistency between the Sinhala Sinhala text and Tamil texts of this Act, the Sinhala text shall prevail.
