An ACT TO AMEND THE SRI LANKA INSTITUTE OF INTERIOR DESIGNERS (Incorporation) Act, No. 2 of 1998

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:—

- 1. This Act may be cited as the Sri Lanka Institute of Short title. Interior Designers (Incorporation) (Amendment) Act, 5 No. of 2016.
 - 2. The aim of the Bill is to amend the section No. 4 of Amendment the Act under the general powers of Corporation, to include of Section 4 General the following:-
- (1) membership in the Corporation is a requirement for Sri Lanka all Practitioners in the filed of Interior Design and Interior Interior 10 Recognition of the Professional Status and Licence Designers for practice of an Interior Designer, Interior (Incorporation) Architect, Interior Technologist and Interior Act, No. 2 of Decorater will be for those who have obtained 15 approval from the Corporation fulfilling the requirements and abiding by the Rules & Regulations and Ethical Code of Practice;
 - (2) the Corporation will be the responsible body to award Charter Status (Chartered Interior Designer) to those who specialize and qualify for such recognition in the field of Interior Design;

- (3) the Corporation will provide a Quality Assurance Certificate for Market Acceptance on such Interior Products of good Designer value and production quality;
- (4) Recommendation by the Corporation will be necessary for the awarding of Certificates for competency in Technical skills in the filed of Interior Decoration and Interior Technology;

 - (5) the Corporation will assist in curriculum development to establish high standards in Interior Design Education.
- 3. In the event of any inconsistency between the Sinhala text to prevail in case of inconsistency.
