STATEMENT OF LEGAL EFFECT

Clause 2 : This clause amends section 431 of the Code of Criminal Procedure Act, No. 15 of 1979 (hereinafter referred to as the "principal enactment") and the legal effect of the section as amended is to—

- (a) make provision to reduce the period granted for a person to establish his claim for seized property taken under section 29 or stolen; and
- (b) increase the value of the property for which notification is required under that section.

Clause 3: This clause amends section 432 of the principal enactment and provides for a consequential amendment to the marginal note of that section.
