AN ACT TO INCORPORATE THE SAMATA SARANA SAHANA SEWA FOUNDATION

WHEREAS a Foundation called and known as the "Samata Preamble. Sarana Sahana Sewa Foundation" has heretofore been established in Sri Lanka for the purpose of effectually carrying out its objects and transacting all matters connected

5 with the said foundation according to the rules agreed to by the members:

AND WHEREAS the said Foundation has heretofore successfully carried out and transacted the several objects and matters for which it was established and has applied to

10 be incorporated and it will be for the public advantage to grant the said application.

1. This Act may be cited as the Samata Sarana Sahana Short title. Sewa Foundation (Incorporation) Act, No. of 2016.

- 2. (1) From and after the date of commencement of this Incorporation 15 Act, such as and so many persons as now are members of the of Samata "Samata Sarana Sahana Sewa Foundation" or shall hereafter Sahana Sewa be admitted as mambers of the Corporation hereby Foundation. constituted, shall be a body corporate with perpetual succession, under the name and style of the "Samata Sarana
- 20 Sahana Sewa Foundation" (hereinafter referred to as the "Corporation") and by that name may sue and be sued with full power and authority to have and use a common seal and to alter the same at its pleasure.

(2) The Corporation shall be deemed to be a voluntary 25 social service organization within the meaning and for the purpose of the Voluntary Social Service Organizations (Registration and Supervision) Act, No. 31 of 1980 and the provisions of that Act be applicable for the management of the affairs of the Corporation.

3. (1) The general objectives for which the Corporation General is constituted are hereby declared to be— objective

objectives of the Corporation.

- (*a*) to provide funds (monetary and non monetary) and organizing awareness programms for less privilege persons;
- (b) to provide basic needs for helpless people which they want basically;
- (c) to uplift the living standards of young persons who have various capabilities through introduce the self employment opportunities and advice them.

(2) In the implementation of the objectives specified in subsection (1) the Corporation shall ensure that such implementation shall be carried out without any distinction based on race, religion, language, cast, sex, political opinion, place of birth or any of such grounds

4. The objects of the Corporation shall be carried out in Corporation such manner so as not to create any conflict between he work of the Corporation and any work being carried out simultaneously by any Ministry or Department of the Ministry or a

20 Government or any Provincial Council.

5. (1) Subject to the provisions of this Act the Management Management and Administration of the affairs of the of the affairs Corporation shall be carried out by a Board of of the Directors(hereinafter referred to as the "Board") consisting

25 of such number of office bearers as may be specified by the rules made under Section 7.

(2)(a) The Board of Directors of the Foundation that holds office on the day immediately preceding the date of commencement of this Act, shall function as the Board of

30 the Corporation until the first Board is appointed or elected in the manner provided for by rules made under Section 7.

(b) The first Board of the Corporation shall be appointed or elected within one year of the date of commencement of this Act.

- (3)(a) Every office bearer of the Board including the patrons and advisors shall be appointed or elcted for a period 5 of three years and any such office bearer, patron or advisor shall be eligible for re-appointment or re-election after lapse of the said period of three years.
- (b) In the event of a vacancy occurring due to the death, 10 resignation, incapacity or removal from office of an office bearer, the Board shall having regard to the rules of the Corporation, elect or appoint a person to fill such vacancy.

(c) The person elected or appointed under paragraph (b) shall hold office only for the unexpired portion of the term 15 of office of the member whom he succeeds

6. Subject to the provisions of this Act and any other Powers of the written law, the Corporation shall have the power to do, Corporation. perform and execute all such acts and matters as necessary or desirable for the promotion or furtherance of the objects of

20 the Corporation or any one of them, including the power:----

- (a) to purchase, acquire, rent, construct, renovate, and otherwise obtain lands or buildings which may be required for the purposes of the corporation and deal with or dispose of the same as many be deemed expedient with a view to promote the objects of the Corporation;
- (b) to barrow or raise funds with or without securities and to receive grants, gifts or donations in cach or goods:
- 30 Provided that the Board shall obtain the prior written approval of the Department of External Resources of the Ministry assigned with the subject

of Finance, in respect of all foreign grants, gifts or donations made to the Corporation;

- (c) to make, draw, accept, discount, endorse, negotiate, buy, sell, and issue bills of exchange, cheques, promissory notes and other negotiable instruments and to open, operate, maintain, and close accounts in any bank;
- (*d*) to invest any funds that are not immediately required for the purpose of the Corporation, in such manner as the Board may determine;
- (e) to undertake, accept, execute, perform and administer any lawful trust or any real or personal property with a view to promote the objects of the Corporation;
- 15 (f) to appoint, employ, dismiss or terminate the services of officers and servants of the Corporation and exercise disciplinary control over them and to pay them such salaries, allowance, and gratuities as may be determined by Corporation;
- 20 (g) to organize lectures, seminars and conferences with a view to promote the objectives of the Corporation.;
 - (h) to liaise and co-ordinate with other local and foreign institutions having similar objects to that of the Corporation;
 - (*i*) to train personnel in Sri Lanka or abroad for the purpose of the Corporation; and
 - (*j*) to do all other things as are necessary or expedient for the proper and effective carrying out of the objects of the Corporation.

7. (1) It shall be lawful for the Corporation, from time to Rules of the time, at any general meeting of the Corporation and by a Corporation. majority of not less than two-thirds of the members with the provisions of this Act or any other written law, for all or any 5 of the following matters:-

- (a) the classification of membership, admission, withdrawal expulsion or resignation of members and fees payable by each class of members;
- (b) the election of the office bearers of the Board or 10 vacation of or removal from office of ofice bearers and the powers, duties, and functions of the office bearers;
 - (c) the terms and conditions of appointment, powers, functions, and duties of the various officers, agents and servants of the Corporation;
 - (d) the procedure to be followed for the summoning and holding of meetings of the Board or any Sub-Committee thereof, notices and agenda of such meetings, the quorum and the Corporation;
- 20 (e) the qualifications and disqualifications to be member of the Board and the Corporation;
 - (f) the administration and management of the property of the Corporation; and
- (g) the management of the affairs of the Corporation 25 and the accomplishment of its objects and dissolution of the Corporation.

(2) Any rules made by the Corporation and may be amended, altered, added to or repealed a like meeting and in like manner, as the rule made under subsection (1) of this 30 Section.

(3) The members of the Corporation shall at all times be subject to the rules of the Corporation.

(4) The rules made under this section shall be published in the Government *Gazette*.

8. The Board shall maintain a registry of members in Registry of which name, address and other essential details of the members.

9.	(1) The Corporation shall have its own Fund.	Fund of the

(2) All monies received by way of gifts, bequests, donations, subscriptions, contributions, fees or grants for and on account of the Corporation shall be deposited in one or more banks

10 approved by the Board to the credit of the Corporation.

(3) There shall be paid out of the Fund, all sums of monies as are required to defray any expenditure incurred by the Corporation in the exercise, performance and discharge of its powers, duties and functions under the Act.

15 **10.** (1) The financial year of the Corporation shall be Accounts and the calendar year. Auditing.

(2) The Corporation shall cause proper accounts to be kept of its income and expenditure, assets and liabilities and all other transactions of the Corporation.

20 (3) The accounts of the Corporation shall be audited annually by the Auditor-General or a qualified auditor appointed by Auditor-General in terms of Article 154 of the Constitution.

(4) For the purpose of this section, "qualified Auditor" 25 means—

(*a*) an individual who being a member of the Institute of Chartered Accountants of Sri Lanka or of any other Institute established by law, possesses a certificate to practice as an Accountant, issued by the Council of such institute; or

(b) a firm of Accountants each of the resident partners of which, being a member of the Institute of Chartered Accountants of Sri Lanka or of any other institute established by law, possesses a certificate to practice as an Accountant, issued by the Council of such Institute.

11. (1) The Board shall prepare a report of the activities Annual Report. of the Corporation for each financial year and submit such report together with the audited statement of accounts to the

10 Secretary of the Ministry of the Minister assigned the subject of Social Services and to the Register of Voluntary Social Service Organization appointed under the Voluntary Social Service Organizations (Registration and Supervision) Act, No. 31 of 1980 before the expiration of six months of the

15 year succeeding the year to which such report is released.

(2) A separate Account relating to the foreign and local moneys received by the Corporation during the financial year shall be attached to the report referred to in subsection (1).

20 **12.** All debts and liabilities of the Foundation existing Debts due by on the day immediately preceding the date of commencement and payable of this Act, shall be paid by the Corporation hereby constituted and all debts due to and subscriptions and contributions payable to the Foundation on that day shall

13. Subject to the provisions of this Act, the Corporation Corporation shall be able and capable in law to take and may hold hold any property, movable or immovable, which may property become vested in it by virtue of any purchase, grant, gift, movable and

30 testamentary disposition or otherwise and all such property immoveble. shall be held by the Corporation for the purposes of this Act and subject to the rules of the Corporation made under Section 7, with power to sell, mortgage, lease, exchange or otherwise dispose of the same.

14. The moneys and property of the Corporation Application however derived shall be applied solely towards the of moneys promotion of the objects of the Corporation and no portion and property. thereof shall be paid or transferred directly or indirectly by

5 way of dividend, bonus or profit to the members of the Corporation.

15. (1) The Seal of the Corporation shall not affixed to Seal of the any instrument whatsoever, except in the presence of two Corporation. members of the Board who shall sign their names to the

10 instrument in token of their presence and such signing shall be independent of the signing of any person as a witness.

(2) The Seal of the Corporation shall be in the custody of an office bearer of the Board as may be decide by such Board.

- **16.** (1) If upon dissolution of the Corporation there Property 15 remains after the satisfaction of all its debts and liabilities remaining on any property whatsoever, such property shall not be dissolution. distributed among the members of the Corporation, but shall be given or transferred to any other institution having objects similar to those of the Corporation and which is by the rules
- 20 thereof, prohibited from distributing any income or property among its members.

(2) For the purposes of subsection (1) the appropriate institution shall be determined by the members of the Corporation immediately before the dissolution at a general
