#### STATEMENT OF LEGAL EFFECT

*Clause 2 :* This clause amends the Long Title to the Sugathadasa National Sports Complex Authority Act, No. 17 of 1999, (hereinafter referred to as the "principal enactment") by widening the scope of the powers of the Sugathadasa National Sports Complex Authority (hereinafter referred to as the "Authority").

Clause 3: This clause introduces a new section 2A to the principal enactment specifying the objects of the Authority.

*Clause 4* : This clause amends section 3 of the principal enactment by providing for the appointment of the Working Director of the Authority.

*Clause 5* : This clause amends section 4 of the principal enactment widening the scope of the functions of the Authority.

Clause 6: This clause amends section 5 of the principal enactment empowering the Authority to achieve its objects.

*Clause 7*: This clause amends the Schedule to the principal enactment, and it is consequential to the amendment made to the principal enactment by clause 4 of this Act.

AN ACT TO AMEND THE SUGATHADASA NATIONAL SPORTS COMPLEX AUTHORITY ACT, NO. 17 OF 1999

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:-

1. This Act may be cited as the Sugathadasa National Short title. Sports Complex Authority (Amendment) Act, No. of 2017.

3. The following new section is hereby inserted Insertion of immediately after section 2 of the principal enactment and shall have effect as section 2A of that enactment:-

(b) improve sports and recreational 20 activities and facilities at the Sugathadasa National Sports Complex to meet the requirements of sports economy and sports tourism;

- (c) provide the facilities available at the Sugathadasa National Sports Complex for the advancement of sports in the country; 5 (d) ensure that sports and recreation are used as tools to support social cohesion and nation building; and (e) make available, on such conditions and on such fees as may be 10 determined by the Board, the facilities of the Sugathadasa National Sports Complex for sports, educational, cultural, and recreational activities.". 15 4. Section 3 of the principal enactment is hereby amended Amendment by the repeal of subsections (3) and (4) of that section and of section 3 of the the substitution therefor of the following subsections:principal enactment. "(3) The Minister shall appoint — (a) one of the members of the Board to be 20 the Chairman of the Authority; and (b) an appointed member of the Board to
  - be the Working Director of the Authority to facilitate the management and administration of the affairs of the Authority.

(4) The provisions of the Schedule to this Act shall have effect in relation to the terms of office of, and the vacation of office by, the Chairman, Working Director and the appointed members of the Board, meetings of the Board and the seal of the Authority.".

Section 4 of the principal enactment is hereby Amendment of section 4 amended in subsection (1) of that section as follows:of the principal (1) by the repeal of paragraph (a) thereof and the enactment. substitution therefor of the following paragraph:-5 "(a) manage, maintain, protect and develop the Sugathadasa National Sports Complex and take necessary measures to safeguard it as a national asset;"; and (2) by the repeal of paragraph (h) thereof and the 10 substitution therefor of the following paragraph:-"(h) make available on such conditions and on such appropriate cost reflective fees as may be determined by the Board, the facilities of the Sugathadasa National Sports 15 Complex for sports, educational, cultural and recreational activities.". 6. Section 5 of the principal enactment is hereby Amendment of section 5 amended as follows:---of the principal (1) by the repeal of paragraph (a) of that section and enactment. the substitution therefor of the following 20 paragraph:-"(a) to purchase and hold property, both movable and immovable, and to give on lease or hire the same;"; and 25 (2)by the repeal of paragraph (j) of that section and the substitution therefor of the following paragraph:---"(i) to do all such other acts as may be necessary, incidental or conducive to the attainment 30 of the objects of the Authority or the

discharge of its functions under this Act.".

7. The Schedule to the principal enactment is hereby Amendment of the Schedule to

(1) by the substitution for item 6 thereof, of the the principal enactment. following item:—

"6. Where the Chairman, the Working Director or any appointed member of the Board is, by reason of illness, absence from Sri Lanka or other cause, temporarily unable to perform the duties of his office, the Minister may, taking into consideration the provisions of section 3, appoint another *ex-officio* member or appointed member, as the case may be, to act as such Chairman, Working Director, or such member.";

- (2) in item 8 thereof, by the substitution for the words
  15 "the Chairman from office" of the words "the Chairman or the Working Director from office";
  - (3) in item 9 thereof, by the substitution for the words "The Chairman may resign from the office of the Chairman" of the words "the Chairman or the Working Director may resign from the office of the Chairman or the Working Director respectively"; and
  - (4) in item 10 thereof, by the substitution for the words"the term of office of the Chairman" of the words"the term of office of the Chairman or the Working Director".

8. In the event of any inconsistency between the Sinhala Sinhala text and Tamil texts of this Act, the Sinhala text shall prevail.
