AN ACT TO AMEND THE INSTITUTE OF PERSONNEL MANAGEMENT, SRI LANKA LAW, NO. 24 OF 1976

WHEREAS the members of the Institute of Personnel Preamble. Management, Sri Lanka, incorporated by the institute of Personnel Management, Sri Lanka Law, No. 24 of 1976 have passed a resolution to amend its name :

5 AND WHEREAS the Institute of Personnel Management, Sri Lanka has applied to amend its name in order to give effect to such resolution, it will be expedient to grant such application:

NOW THEREFORE be it enacted by the Parliament of the 10 Democratic Socialist Republic of Sri Lanka as follows :----

1. This Act may be cited as the Institute of Personnel Short title. Management, Sri Lanka (Amendment) Act, No. of 2018.

2. (1) The Institute of Personnel Management, Sri Lanka Amendment Law, No. 24 of 1976 (hereinafter referred to as the "principal of Law, No. 15 enactment") is hereby amended by the substitution for the words "Institute of Personnel Management, Sri Lanka" law & etc. wherever they appear in the principal enactment of the words "Chartered Institute of Personnel Management, Sri Lanka".

(2) In any written law, there shall be substituted for the 20 words "Institute of Personnel Management, Sri Lanka" of the words "Chartered Institute of Personnel Management, Sri Lanka".

(3) Every reference to the "Institute of Personnel Management, Sri Lanka" in any notice, contract, 25 communication or other document shall be read and construed as a reference to the "Chartered Institute of Personnel Management, Sri Lanka".

3. Any power exercised, duty or function performed by Validity of the Institute of Personnel Management, Sri Lanka prior to acts done the Institute of Personnel Management, Sri Lanka prior to the the date of commencement of this Act in pursuance of any power conferred on it by the principal enactment shall be of this Act.
