AN ACT TO PROVIDE FOR THE ESTABLISHMENT OF A TRUST CALLED THE GALAHA BHADDRAWATHIE NATIONAL BHIKKHU CARE CENTRE TRUST AND FOR MATTERS CONNECTED THEREWITH OR INCIDENTAL THERETO.

WHEREAS a Trust called and known as the "Galaha Preamble Bhaddrawathie National Bhikkhu Care Centre Trust" has heretofore been established by a Public Trust dated February 7, 2003 for the purpose of establishing and maintaining a

5 Bhikkhu Care Centre, for Bhikkhus who are sick and helpless:

AND WHEREAS it has now become apparent that the said Trust is not functioning properly and therefore it is not possible to maintain the said Galaha Bhaddrawathie National Bhikkhu Care Centre due to various reasons including the absence of

10 proper administration in the said Galaha Bhaddrawathie National Bhikkhu Care Centre and the absence of a regular and adequate funding system for the proper functioning of the said Galaha Bhaddrawathie National Bhikkhu Care Centre:

AND WHEREAS it has become necessary to enact legislation 15 to provide for the establishment of a Trust called the Galaha Bhaddrawathie National Bhikkhu Care Centre Trust to achieve the objects of the said Galaha Bhaddrawathie National Bhikkhu Care Centre for the benefit of the Bhikkhus who are sick and helpless and to matters connected therewith

20 or incidental thereto:

NOW THEREFORE BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:-

1. This Act may be cited as the Galaha Bhaddrawathie Short title National Bhikkhu Care Centre Trust Act, No. of 2022.

25 2. (1) There shall be established a Trust to be called the Establishment Galaha Bhaddrawathie National Bhikkhu Care Centre Trust of the Galaha (hereinafter referred to as the "Trust"). National

4. The functions of the Trust are –

(2) The Trust shall, by the name assigned to it by subsection (1), be a body corporate and shall have perpetual succession and by that name may sue and be sued with full power and authority to have, and use a common seal and to alter the same.

3. The object of the Trust shall be to facilitate the The object of accommodation and caring for sick and helpless Bhikkhus the Trust in the Galaha Bhaddrawathie National Bhikkhu Care Centre (hereinafter referred to as the "Bhikkhu Care Centre").

> (a) to maintain the Galaha Bhaddrawathie National Bhikkhu Care Centre for Bhikkhus who are sick and helpless and accommodate sick and helpless Bhikkhus in the Bhikkhu

> (b) to provide the Bhikkhus residing in the Bhikkhu Care Centre who are sick, with all the necessities including the day to day requirements and to facilitate the obtaining

of medicines and medical treatment;

(c) to organize and conduct meditation programmes and other Buddhist programmes for the Bhikkhus residing in the Bhikkhu Care

(3) Any person who has become a member of the Board in his *ex-offficio* capacity shall hold office as long as he holds such office by virtue of which he is a member of the Board.

- 15 (4) Any appointed member of the Board shall unless a vacancy arises in his post by resignation, death or removal from office, hold office for three years from the date of appointment. Any member whose term is due to end otherwise than by removal shall be eligible for reappointment. Such
- 20 reappointment shall be for not more than one further term, whether consecutive or not.

(5) In the event of the vacation of office by death, resignation or removal of any appointed member, the Minister shall, subject to paragraph (b) of subsection (2), appoint 25 another person to fill such vacancy and such person shall

hold office for the un-expired period of the term of office of the member whom he succeeds.

(6) Any appointed member who is temporarily unable to discharge his duties and functions as a member of the Board30 due to ill health, infirmity, being absent from Sri Lanka or for other reason for not less than three months shall inform that to the Minister in writing. In such event the Minister shall having regard to the provisions of subsection (2), appoint another person to act in the place of such member.

purpose of this Act to sell, mortgage, lease, grant, convey, device, assign, exchange or otherwise dispose of any property to which the Trust may become entitled to;

- (c) to enter into and perform, either directly or through 5 officers, employees and agents authorized in that behalf by the Board, all such contracts and agreements as may be necessary for the exercise, performance and discharge of the powers, duties and functions of the Trust; and
 - (d) to open, operate and close bank accounts in any Bank as may be recommended by the Board.

8. The conditions and criteria for accommodating Accommodation Bhikkhus in the Bhikkhu Care Centre and caring for such etc. of Bhikkhus 15 Bhikkhus shall be as prescribed by regulations.

9. The Trust shall be capable in law to take and hold Power of the property, movable or immovable, which may become vested Trust to hold property in it by virtue of any purchase, grant, gift, testamentary disposition or otherwise and all such property shall be held 20 by the Trust for the purposes of this Act.

10. (1) Meetings of the Board shall be held at least once Meetings of the Board in three months.

(2) The Chairman shall, if present preside at every meeting of the Board. In the absence of the Chairman from any 25 meeting of the Board, the members present at such meeting shall elect from among themselves a member to preside at such meeting.

(3) The quorum for any meeting of the Board shall be nine members.

(4) If there is an equality of votes at any meeting, the Chairman or the member presiding at such meeting shall in addition to his vote, have a casting vote.

(5) The Board may subject to the provisions of this Act regulate the procedure to be followed in regard to its meetings 5 and the transaction of its business.

(6) No act, decision or proceeding of the Board shall be deemed to be invalid by reason only of the existence of a vacancy among its members or any defect in the appointment 10 of any member thereof.

11. The members of the Board may be paid such Remuneration remuneration for attendance at meetings of the Board as for attending the meetings may be determined by the Minister with the concurrence of of the Board the Minister assigned the subject of Finance.

- 15 12. There shall be an advisory committee consisting of Advisory Committee the Mahanayake Theros of the Malwathu, Asgiri, Amarapura and Ramanna Chapters to advise the Board on matters relating to the Bhikkhu Care Centre.
- 13. (1) There shall be established a Fund called the Establishment 20 Galaha Bhaddrawathie National Bhikkhu Care Centre Trust of Galaha Bhaddrawathie Fund (hereinafter referred to as the "Fund"). The management, administration, control and operation of the Bhikkhu Care Fund shall be vested in the Board.

(2) There shall be paid into the Fund-

(a) all such sums of monies allocated by the Parliament, from time to time, for the purpose of carrying out the objects of the Fund;

> (b) any grant, gift or donation in cash or kind, from Sri Lanka or outside to achieve the objects of the Fund, subject to section 7(2)(a).

(3) There shall be paid out of the Fund all such sums of money required to defray the expenditure incurred by the Trust in the exercise, performance and discharge of its powers, duties and functions under this Act.

15. (1) At the request of the Board, any officer in the Appointment public service may, with the consent of that officer and of of public the Public Service Commission be temporarily appointed to

20 the staff of the Trust for such period as may be determined by the Board, or with like consent, be permanently appointed to such staff.

(2) Where any officer in the public service is temporarily appointed to the staff of the Trust the provisions of

25 subsection (2) of section 14 of the National Transport Commission Act, No. 37 of 1991 shall, mutatis mutandis, apply to and in relation to such officer.

(3) Where any officer in the public service is permanently appointed to the staff of the Trust the provisions of 30 subsection (3) of section 14 of the National Transport

Commission Act, No. 37 of 1991 shall, mutatis mutandis, apply to and in relation to such officer.

16. (1) The financial year of the Trust shall be the Financial year and audit of

audit of accounts

(2) The Board shall cause proper books of accounts to be kept of the income and expenditure of the Trust.

5 (3) The provisions of Article 154 of the Constitution relating to the audit of accounts of Public Corporations shall apply to the audit of accounts of the Trust.

17. (1) The Board shall within six months of the end of Annual each financial year submit to the Minister an annual report reports
10 on the activities carried out by the Trust along with the audited accounts of the Trust for the year.

(2) The Minister shall within three months from the date of receipt of the annual report, table such report along with the documents specified in subsection (1) in Parliament for15 its consideration.

(2) The Board shall maintain a register in respect of the instruments and documents to which the seal of the Board is affixed.

19. (1) Any expense incurred by the Trust in any suit or Recovery of prosecution brought by, or against the Trust before any court, expenses from any suit 5 shall be paid out of the moneys of the Fund and any cost or recovered by the Trust in any such suit or prosecution shall prosecution be credited to the Fund.

(2) Any expense incurred by any member of the Board or 10 any officer or employee of the Trust in any suit or prosecution brought against him in any court in respect of any act which is done or purported to be done by him under this Act or on the direction of the Board shall, if the court holds that such act was done in good faith, be paid out of the Fund unless

15 such expense is recovered by him in such suit or prosecution.

20. (1) The Minister may in consultation with the Regulations Mahanayaka Theros of the Malwathu, Asgiri, Amarapura and Ramanna Chapters, make regulations for matters required by this Act to be prescribed or in respect of which regulations 20 are authorized to be made.

(2) Every regulation made by the Minister shall be published in the Gazette and shall come into operation on the date of such publication or such later date as may be specified in such regulations.

25 (3) Every regulation made by the Minister shall within three months after its publication in the Gazette, be brought before Parliament for its approval. Every regulation which is not so approved by Parliament shall be deemed to be rescinded as from the date of such disapproval, but without 30 prejudice to anything previously done thereunder.

(4) Notice of the date on which any regulation is so disapproved shall be published in the Gazette.

21. (1) The Board may make rules in respect of all Rules matters authorized to be made by this Act.

(2) Without prejudice to the generality of the provisions of subsection (1), rules may be made in respect of all or any5 of the following matters:-
