AN ACT TO INCORPORATE THE SRI SEELANANDA FOUNDATION

WHEREAS a Foundation called and known as the Preamble
"Sri Seelananda Foundation" has heretofore been formed in
Sri Lanka for the purpose of effectually carrying out and
transacting all objects and matters connected with the said
5 Foundation according to the rules agreed to by its members:

AND WHEREAS the said Foundation has heretofore successfully carried out and transacted the several objects and matters for which it was formed and has applied to be incorporated and it will be for the public advantage to grant

10 such application:

BE it therefore, enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:—

1. This Act may be cited as the Sri Seelananda Foundation Short title (Incorporation) Act, No. of 2022.

- 2. From and after the date of commencement of this Act, Incorporation such and so many persons as now are members of the of Sri "Sri Seelananda Foundation" (hereinafter referred to as the Seelananda "Foundation") or shall hereafter be admitted as members of Foundation the Corporation hereby constituted, shall be a body corporate
- 20 with perpetual succession, under the name and style of "Sri Seelananda Foundation" (hereinafter referred to as the "Corporation") and by that name may sue and be sued and have full power and authority to have and use a common seal and alter the same at its pleasure.
 - **3.** The general objects for which the Corporation is General objects of the
 - constituted are hereby declared to be— Corporation
 - (*a*) to participate in social, cultural and economic development of the country;

- (b) to take measures to protect the discipline and cultural values of the people;
- (c) to give assistance to develop worships places;
- (d) to work towards to protect and develop all rights of women and children; and
- (e) to promote peace, goodwill, understanding and co-operation among all communities and people of Sri Lanka.
- 4. (1) The affairs of the Corporation shall, subject to the Management 10 other provisions of this Act and the rules in force for the time of the affairs being of the Corporation be administered by a Committee of the Corporation of Management, consisting of Chairman, Secretary, Treasurer and another eleven members elected in accordance with such rules.
- 15 (2) The first Committee of Management shall consist of the members of the Committee of Management holding office on the day immediately preceding the date of commencement of this Act.
- 5. Subject to the provisions of this Act and any other General 20 written law, the Corporation shall have the power to do, perform and execute all such acts, matters and things whatsoever as are necessary or desirable for the promotion or furtherance of the objects of the Corporation or any one of them, including the power to acquire and hold property
- 25 movable, to open, operate or close bank accounts, to borrow or raise moneys with or without security, to erect any building or structure on any land held by the Corporation and to engage, employ and dismiss officers and servants required for the carrying out of the objects of the Corporation.
- 30 6. (1) It shall be lawful for the Corporation, from time to Rules of the time, at any general meeting and by a majority of less than Corporation two-thirds of the members present to make rules, not inconsistent with the provisions of this Act or any other written law, on all or any of the following matters:-

Powers of the Corporation

- (a) the classification of members, and the admission, withdrawal, expulsion of members;
- (b) the election of office bearers, the resignation from, vacation of or removal from office of office bearers and their powers, conduct and duties;

- (c) the election and duration of the members of the Committee of the Management and its powers, conduct and duties;
- (d) the powers, conduct, duties and functions of the 10 various officers, agents and servants of the Corporation;
 - (e) the procedure to be observed at and the summoning and holding of meetings of the Committee of Management or sub Committee and of the time, places, notices and agenda of such meetings, the quorum thereof and the conduct of business thereof;
 - (f) the administration and management of the property of the Corporation, the custody of its funds and the maintenance and audit of its accounts ; and
- 20 (g) the management of the affairs of the Corporation, and the accomplishment of its objects.

Any rule made by the Corporation may be (2)amended, altered, added to or rescinded at a like meeting and in like manner as a rule made under subsection (1).

Every member of the Corporation shall be subject 25 (3) to the rules of the Corporation.

7. All debts and liabilities of the Foundation on the day Debts due by preceding the date of commencement of this Act, shall be and payable paid and discharge by the Corporation hereby constituted, to the Foundation

30 and all debts due to, subscriptions and contributions payable to the Foundation on that day shall be paid to the Corporation for the purpose of this Act.

8. (1) The Corporation shall have its own fund and all Fund of the corporation moneys heretofore or hereafter to be received by way of gifts, bequest, donation, subscription, contribution, fees or grants for and on account of the Corporation shall be deposited to

the credit of the Corperation in one or more banks as the 5 Committee of Management shall determine.

(2) There shall be paid out of the fund, all sums of money required to defray any expenditure incurred by the Corporation in the exercise, performance and discharge of 10 its powers, duties and functions under this Act.

9. The Corporation shall be able and capable in law, to Corporation acquire and hold any property, movable or immovable which may hold may become vested in it by virtue of any purchase, grant, property

- lease, gift, testamentary disposition or otherwise, and all immovable 15 such property shall be held by the Corporation for the purposes of this Act and subject to the rules under Section 06 of the Corportion, with full power to sell, mortgage, lease, exchange or otherwise dispose of the same.
- 10. If upon the dissolution of the Corporation there Property 20 remains after the satisfaction of all its debts and liabilities, remaining on any property whatsoever, such property shall not be distributed among the members of the Corporation, but shall be given or transferred to some other institution or institutions having objects similar to those of the Corporation
- 25 and which is or are by its or their rules prohibited from distributing any income or property among there members.

11. (1) The financial year of the Corporation shall be Audit and the calendar year.

(2) The Corporation shall cause proper accounts to be 30 kept of all moneys received and expended, by the

Corporation.

movable or

(3) The accounts of the Corporation shall be examined and audited at least once in every year and the correctness of income and expenditure account and balance sheet certified by a qualified auditor appointed by the Committee of 5 Management.

(4) In this section "qualified auditor" means-

(a) an individual who, being a member of the Institute of Chartered Accountants of Sri Lanka, or any other institute established by law, possesses a certificate to practice as an Accountant issued by the Council of such institute; or

(b) a firm of Accountants each of the resident partners of which, being a member of the Institute of Chartered Accountants of Sri Lanka or any other institute established by law, possesses a certificate to practice as an Accountant issued by the Council of such institute.

20 12. The seal of the Corporation shall not be affixed to Seal of the any instrument whatsoever, except in the presence of two Corporation members of the Committee of Management, who shall sign their names to the instrument in token of their presence and such signing shall be independent of the signing of any person 25 as a witness.

13. Nothing in this Act contained shall prejudice or Saving of the affect the rights of the Republic or of anybody politic, or rights of the corporate or of any other persons expect such as are Republic and mentioned in this Act and those claiming by, from or under

others

30 them.

14. In the event of any inconsistency between the Sinhala text Sinhala and Tamil texts of this Act, the Sinhala text shall to prevail in case of prevail. inconsistency
