#### STATEMENT OF LEGAL EFFECT

*Clause 2*: This clause amends section 442 of the Code of Criminal Procedure Act, No. 15 of 1979 (hereinafter referred to as the "principal enactment") and the legal effect of the amendment is to make provision to issue one certified copy of the judgment or final order of the record to each of the parties to the case free of charge.

Clause 3: This clause amends section 443 of the principal enactment and is consequential to the amendment made by clause 2.

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows: -
