STATEMENT OF LEGAL EFFECT

Clause 2: This clause amends section 5_A of the High Court of the Provinces (Special Provisions) Act, No. 19 of 1990, and the legal effect of the amendment is to enable the High Court of the Provinces to hear the appeals from the Small Claims Court.

AN ACT TO AMEND THE HIGH COURT OF THE PROVINCES (SPECIAL PROVISIONS) ACT, No. 19 of 1990

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows: -

1. (1) This Act may be cited as the High Court of the Short title Provinces (Special Provisions) (Amendment) Act, No. of and date of 2022.

- (2) The provisions of this Act shall come into operation on such date as the Minister may appoint by Order published in the Gazette.
- 2. Section 5A of the High Court of the Provinces (Special Amendment 10 Provisions) Act, No. 19 of 1990 is hereby amended as of section 5A follows: -

- (1) in subsection (1) thereof, by the substitution for the words "District Court or a Family Court", of the words "District Court, Family Court or Small Claims Court" and for the words "District Court or Family Court", of the words "of a District Court, of a Family Court or of a Small Claims Court";
- in subsection (2) thereof, by the substitution for the words "of a District Court or a Family Court,", of 20 the words "of a District Court, of a Family Court or of a Small Claims Court," wherever they occur in that subsection; and
- (3) in the marginal note to that section by the substitution for the words "District Courts and Family Courts.", of the words "District Courts, Family Courts 25 and Small Claims Courts.".
 - 3. In the event of any inconsistency between the Sinhala Sinhala text and Tamil texts of this Act, the Sinhala text shall prevail.
