STATEMENT OF LEGAL EFFECT

Clause 2 : This clause amends section 19 of the Medical Ordinance (Chapter 105) (hereinafter referred to as the "principal enactment") in order to add certain matters in respect of which regulations can be made by the Minister.

Clause 3 : This clause amends section 19c of the principal enactment and the legal effect of the section as amended is to provide for the appointment of a Committee to advice the Minister regarding any recommendation made by the Medical Council in respect of any recognized university or institution under subsection (1) of section 19c.

Clause 4: This clause amends section 19E of the principal enactment for better explanation of the term "any university or institution".

Clause 5: This clause amends section 29 of the principal enactment and is consequential to the amendment made by clause 2.

AN ACT TO AMEND THE MEDICAL ORDINANCE (CHAPTER 105)

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows: -

1. This Act may be cited as the Medical (Amendment) Short title Act, No. of 2024.

"(2A) Upon receipt of any comments from a recognized university or institution under subsection (2), the Minister shall refer such comments together with the recommendation made by the Medical Council under subsection (1) to a committee consisting of the following members:-

- (a) the Additional Secretary (Medical Services) of the Ministry of the Minister assigned the subject of Health;
 - (b) the Director-General of Health Services of the Ministry of the Minister assigned the subject of Health; and
 - (c) three other eminent professors in the field of medicine nominated by the Secretary to the Ministry of the Minister assigned the subject of Health in consultation with the University Grants Commission.
