STATEMENT OF LEGAL EFFECT

Clause 2: This clause amends the Long Title to the Licensing of Shipping Agents, Freight Forwarders, Non-Vessel Operating Common Carriers and Container Operators Act, No.10 of 1972 and the legal effect of that section as amended is to discontinue the application of the provisions of the principal enactment to container operators.

Clauses 3, 4 and 5: The amendments done by these clauses are consequential to the amendment made by clause 2.

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows: -

5. With effect from the date of commencement of this Sa Act, notwithstanding any provision in any other law-
