STATEMENT OF LEGAL EFFECT

Clause 2: This clause amends the section 7 of the Sri Lanka Institute of Architects Law, No.1 of 1976 (hereinafter referred to as the "principal enactment") and the legal effect of that section as amended is to provide for those who have been enrolled as Associates to the Institute on the day immediately preceding the date of coming into operation of this Act, to be considered as members of the Institute.

Clause 3: This clause amends section 12 of the principal enactment and is consequential to the amendment made by the clause 2.

Clause 4: This clause is consequential to the amendment made by the clause 2.

AN ACT TO AMEND THE SRI LANKA INSTITUTE OF ARCHITECTS LAW, No. 1 of 1976

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:-

- 1. This Act may be cited as the Sri Lanka Institute of Short title Architects (Amendment) Act, No. of 2025.
- 2. Section 7 of the Sri Lanka Institute of Architects Amendment 5 Law, No. 1 of 1976 (hereinafter referred to as the "principal" enactment") is hereby amended in subsection (1) thereof, by 1976 the substitution for all the words starting from "The corporate members" to the word, "Associates:" of the following:-

- "(4) Except as provided in this section, no person or body of persons shall take or use the title "Chartered Architect" or "Chartered Architects" or the initials "F.I.A (Sri Lanka)" or "M.I.A (Sri Lanka)", or use the same as the name or part of the name in any book, journal or other publication, dealing with architecture, design or the practice of architecture or the profession of architecture "

For the avoidance of doubts, it is hereby declared that, Avoidance of 10 those who have been enrolled as Associates to the Institute on the day immediately preceding the date of coming into operation of this Act, shall, with effect from the date of coming into operation of this Act, be deemed to be members 15 of the Institute.
