#### THE PRADESHIYA SABHAS ACT, No. 15 OF 1987

#### Order

BY virtue of the powers vested in me by Paragraphs (*a*) and (*b*) of Section 9A of the Pradeshiya Sabhas Act, No. 15 of 1987, I, Janaka Bandara Tennakoon, Minister of Local Government and Provincial Councils, do hereby amend the Order published in *Gazette Extraordinary*, No. 453/8 of May 12, 1987 relating to the Constitution of the Dambulla Pradeshiya Sabha, As follows :—

- (1) By the deletion of Schedule thereto and substitution of Schedule hereto;
- (2) (a) By the repeal of the word "nine" in the fourth paragraph of the said order and the substitution of the word "thirteen"; and
  - (b) The above Order shall come into force with effect from the first day of April, 2011.

#### Part - II

#### Administrative Limits of the Dambulla Pradeshiya Sabha :

#### North:

Beginning by a line drawn from the point on the common boundary of North Central Province and Central Province, located at a distance of 800 metres Northwards from the summit of Inamaluwa hill which is located on the common boundary of North Central and Central Provinces, Eastwards up to a point on the boundary of Anuradhapura and Polonnaruwa districts (*i.e.* up to Nambadagala), thence Eastwards along the common boundary of North Central and Central Provinces up to the point on the centre line of Kiri Oya, thence 4800 metres Eastwards along the common boundary of North Central and Central and Central Provinces ;

#### East:

From the last mentioned point Southwards along the common boundary of North Central and Central Provinces up to the point on the anicut of Heerat Oya;

#### South :

From the last mentioned point 800 metres North Westwards along the Heerat Oya, thence 1600 metres Westwards along the common boundary of North Central and Central Provinces, thence 800 metres Northwards and 8000 metres South Westwards over the summits of Kandubadayaya hill and Vehigala hill, thence Southwards up to the summit of Gedaragalpathana hill, thence along Northern boundaries of Udahaduwa, Serudandapola, Karawilahena, Nikula and Usatthawa villages up to a point on the centre line of Mala Oya ;

#### West:

From the last mentioned point 4800 metres Northwards along the centre line of said Oya up to a point on the boundary of Pahalawewa village marked by boundary stones, thence along the Eastern boundaries of Pahalawewa and Thalakiriyagama villages marked by boundary stones up to the Centre line of Dambulu Oya, thence South Eastwards along the centre line of Dambulu Oya passing the 100 Acres road and the boundary of Embulambe and up to the Centre line of Matale-Dambulla main road, thence again South Eastwards along the centre line of Dambulu Oya up to Madamulla Ela, where the boundaries of Kiralessa and Embulambe villages meet, thence Eastwards along the centre line of Medamulla Ela up to the common boundary of Diyabubulawattha owned by Lucky Gamini Senanayaka and M.P.S. Wattha owned by Marawanagoda, thence Northwards along the said common boundary up to the centre line of Dambulu Oya- Kalundewa Road, thence Eastwards along the the said road up to the common boundary of Nadukarawattha owned by Palliyaguru and M. P. S. #### MUNICIPAL COUNCILS ORDINANCE

#### Order

BY virtue of the powers vested in me by Sections 2, 3, 5 and 9 of the Municipal Councils Ordinance (Cahpter 252), I, Janaka Bandara Tennakoon, Minister of Local Government and Provincial Councils, do by this Order —

- (1) declare the area specified in Part I of the Schedule hereto, to be a Municipality for the purposes of that Ordinance ;
- (2) define the limits of the Municipality to be the limits set out in Part II of that Schedule ;
- (3) Constitute a Municipal Council for the Municipality declared under paragraph (1) of the Order and assign the following name and designation to such Council ;

#### "DAMBULLA MUNICIPAL COUNCIL"

- (4) prescribe that the Dambulla Municipal Council shall consist of the Mayor, the Deputy Mayor and thirteen other Councilors;
- (5) appoint the first day of April 2011, as the date on which the term of office of the Dambulla Municipal Council shall commence.

#### Part - I

#### North :

Beginning by a line drawn from the point where on the common boundary of North Central and Central Provinces, intersects the centre line of Dambulu Oya, Eastwards along the common boundary of North Central and Central Provinces, marked by boundary stones, thence North Westwards along the centre line of Mirisgoni Oya up to the point where it meets the boundary of Hinguruwelpitiya and Bulagala villages, thence thence North Eastwards along the boundary of Provinces and across the Dambulla - Anuradhapura highway, thence 1700 metres North Eastwards along the boundary of Provinces and Eastwards along the Northern boundary of Bulagala village up to the Mehaweli Waterway and South Eastwards along the said waterway up to Kethela and Southwards along the said Ela up to the centre line of Randeni Ela, thence Eastwards along the centerline of Randeni Ela and North Eastwards along the said Ela up to the bund of the Randeni Tank and across the tank bund and sluice and South Eastwards along the said road up to the centre line of Serugasyaya road, thence Eastwards along the centre line of the said road up to the centre line of Serugasyaya road, thence Eastwards along the centre line of the said road up to the common boundary of F.V.P. 418 Inamaluwa and F.V.P. 421 Pelwehera, which is marked by boundary stoes and across the Mahaweli Waterway and Southwards along the common boundary of F.V.P. 420 Kandalama and F.V.P. 421 Pelwehera villages ;

#### East:

Thence along the centre line of Mirisgoni Oya up to the centre line of Yakkuragala Oya, thence Southwards along the centre line of Yakkuragala Oya up to the point where Panugalugoda Oya flows in to the Yakkuragala Oya, thence Southwards along the boundary of F.V.P. 420 Kandalama, F. V. P. 424 Rathmalgahaela and Yakkuragala villages up to the centre line of Yakkuragala Oya, thence along the said Oya up to the centre line of Dambulla - Kandalama main road, thence Southwards along the centre line of Yakkuragala and Rathmalgaha Ela villages marked by boundary stones, thence Southwards along the said Ela up to the common boundary of Yakkuragala and Rathmalgaha Ela villages marked by boundary stones, thence Southwards along the said boundary of Thitthawelgolla and Rathmalgaha Ela villages, thence, Southwards across the centre line of Thitthawelgolla Dola up to the common boundary of Kalogaha Ela/Bimthambura villages, thence Eastwards along the said boundary up to the boundary of Keeralessa and Kalogaha villages up to the Nadukarawattha owned by Palliyaguru and M. P. S. Wattha owned by Marawanagoda, thence Southwards along the said boundary up to the centre line of the road leading from Dambulu Oya to Kalundewa ;

#### South :

Westwards from the Northern end of the common boundary of Bimthambura/Kalogaha Ela and Keerelessa villages (from the centre line of Kalundewa road) up to the common boundary of Diyabubula wattha owned by Lucky Gamini Senevirathna and M. P. S. Watthe owned by Marawanagoda, thence Southwards along the said common boundary up to the centre line of Medamulla Ela, thence along the Medamulla Ela up to the centre line of Dambulu Oya, thence along the centre line of Dambulu Oya up to the centre line of Matale - Dambulla main road (Dambulu Oya Bridge) thence along the centre line of Dambulu Oya up to the 100 Acress road where the boundaries of Embulambe and Kapuwattha meets the said road ;

#### West:

Old Welamitiya Oya within the Ibbankatuwa reservoir, thence, Northwards along the centre line of Old Dambulu Oya within the Ibbankatuwa reservoir up to the point where it meets the boundaries of Thubare and Dandubendiruppu villages, thence along the cente line of old Dambulu Oya within the Ibbankatuwa reservoir up to the common boundary of Dandubendiruppa and Anakatawewa villages, which is also the common boundary of North Central and Central Provinces, thence Northwards along the centre line of Old Dambulu Oya within the Ibbankatuwa reservoir and the boundary of North -Central and Central Provinces and across the bund of Dambulua reservoir and again Northwards along the centre line of Dambulu Oya which is lyling along the common boundary of North Central and Central Provinces up to the boundary of North Central and Central Provinces and across the bund of Dambulua reservoir and again Northwards along the centre line of Dambulu Oya which is lyling along the common boundary of North Central and Central Provinces up to the boundaries of Anakata wewa and Hinguruwelpitiya villages.
