Order under Section 03

SCHEDULE

DEIYANDARA URBAN DEVELOPMENT AREA

Column I

The entire land area surrounded by metes and bounds of following GS Divisions as described in Column II.

No. 275 Deiyandara, No. 272 A Neralampitiya, No. 275 C Galatumba No. 275 D Maduwala, of Mulatiyana Pradeshiya Sabha Area in the Matara District of the Southern Province, (Mulatiyana Divisional Secretariat Division).

Column II

North :

From the intersection of the centre line of Ovilana Ela and centre line of Baratakumbura Ela meets, a line drawn towards Northeastwards, Eastwards and Northeastwards along the centre line of Baratakumbura Ela until it meets the centre line of Kalugaladeniyapokuna Ela ; thence, a line drawn Northeastwards and Northwestwards along the centre line of the said Pokuna Ela until it meets the extended Southern boundary of Kohilagahadeniya land towards west, thence a line drawn towards East along the Southern border of the

said land until it meets the centre line of Deiyandara-Handugala Road ; thence, a line drawn towards Northeastwards along the centre line of the said road until it meets the centre line of 3/2 Culvert over Pita Ela ; thence a line drawn South-eastwards along the centre line of the said Ela until it meets the Centre line of Kirama Ara.

East :

From the last mentioned point a line drawn Southeast wards and Southwestwards along the centre line of Kirama Ara until it meets the Centre line of Panditha Poruwa Road Bridge (Mahaokanda Bridge) ; thence, a line drawn Southeastwards, northeastwards and Southeastwards along the centre line of Panditha Poruwa Road until it meets the Centre line of Deiyandara-Kirama Road ; thence, a line drawn Southwestwards and Southeastwards along the centre line of the said road until it meets a point at 1.9 km.

South :

From the last mentioned point, a line drawn Southwestwards along the centre line of Deiyandara-Kirama Road until it meets the centre line of Denagama-Mulatiyan Road ; thence, a line drawn towards South along the centre line of the said road until it meets centre line of 9/1 culvert (at Kopiwatta Culvert) ; thence, a line drawn towards South-west along the centre line of Kopiwatta Ela until it meets centre line of distributory which flows from Wawalapiyadda ; thence, a line drawn towards North along the centre line of the said distributory until it meets the Centre line of Kirama Ara ; thence, a line drawn towards North-west, West, South-west, North and Southwest along the centre line of Kiramba Ara until it meets the centre line of the Seenipalla Bridge.

West :

From the last mentioned point, a line drawn towards North-west along the centre line of Kirama Ara until it meets the centre line of Ovilana Ela ; thence, a line drawn towards North-east, North-west and Northeast along the centre line of Ovilana Ela until it meets the starting point.
