THE LAND ACQUISITION ACT (CHAPTER 460)

I hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired:

Seven (07) allotments of land in total extent of about 1.1016 Hectares, depicted in F.V.P. 2486, Paper 3, Supplementary Plan No. 2, situated in the village of Walpaluwa in Walpaluwa Grama Niladhari Division, No. 1254 in Dewamedda Korale Sub Division in the Divisional Secretary's Division of Wariyapola in Kurunegala District in North Western Province and described as follows:

1. Lot No. 12

Name of land: Walpaluwe Mukalana; Description: Paddy field, contain a well and 5 coconut trees between 10-15 years old; Claimant: Mohottala Don Wickramarathna, Weherayagama, Minuwangate; Extent: 0.1452 Hectare.
