THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Fourteen (14) allotments of land whose names and extent are below in total extent of about 0.0112 Hectare, depicted as Lot 'A' to 'Q' in Advance Tracing No. KE/RWN/2009/50 and dated on 04th April, 2009, prepared by the Surveyor-General, situated in the village of Ruwanwella, in Megodapothapattuwa Minor Division in the Divisional Secretary's Division of Ruwanwella, in the District of Kegalle in Sabaragamuwa Province:

- 01. Lot 'A' – Raththanakotuwwatta – Extent: 0.0017 Hectare**

North: Portion of the same land; East: Raththanakotuwwatta; South: Road (RDA); West: Lot F.

08. Lot 'H' – Raththanakotuwwatta – Extent: 0.0008 Hectare
North and East: Road (RDA); South: Raththanakotuwwatta; West: Lot J.

09. Lot 'J' – Raththanakotuwwatta – Extent: 0.0007 Hectare
North: Road (RDA); East: Lot H; South: Portion of the same land; West: Lot K.

10. Lot 'K' – Raththanakotuwwatta – Extent: 0.0005 Hectare
North: Road (RDA); East: Lot J; South: Portion of the same land; West: Lot M.

11. Lot 'M' – Raththanakotuwwatta – Extent: 0.0004 Hectare
North: Road (RDA); East: Lot K; South: Portion of the same land; West: Lot N.

12. Lot 'N' – Raththanakotuwwatta – Extent: 0.0012 Hectare
North: Road (RDA); East: Lot M; South: Portion of the same land; West: Lot P.

13. Lot 'P' – Raththanakotuwwatta – Extent: 0.0001 Hectare
