SCHEDULE I

KILLINOCHCHI URBAN DEVELOPMENT AREA

Column I

All that area of land falling within the following Grama Seva Niladhari Divisions situated in the Divisional Secretary Divisions of Karachchi and Kandawalai in the Killinochchi District in the Northern Province and bounded by metes and bound as specified in Column - II

(i) Karachchi Divisional Secretariat Division.

Column II

North :

From a point at a distance of 3.5 KM from A9 road towards West along North Kumarapuram -Paranthan village boundary, a line drawn along that Kumarapuram Paranthan village boundary towards East, until it cross the center line of A9 Road and extend 500 meters, thence towards South to a distance of 1.6 KM thence towards East parallel to Puthukkudiyirupy Road to a distance of 3.5 Km.

East :

From the last mentioned point a line drawn towards South to a distance of 1.2 Km until it meets the center line of the Puthukkudiyiruppu - Paranthan Road thence towards West along the said Paranthan - Puthukkudiyiruppu road to a distance of 2.0 Km. until its meets a points 1.6 Km away from Paranthan Junction. Thence a line drawn towards South along the road until its meets the Iranamadu main road. Thence towards South along the said Iranamadu Road until it meets Northern District boundary of Mulaithivu.

South :

From the last mentioned point a line drawn towards West along the said Mullaithivu District boundary crossing A9 Road. Until its meets the Akkarayankulam - Ponnagar Village Boundary (Reference Kilinochchi 1 : 50.000 sheet).

West :

From the last mentioned point, a line drawn towards North-West along the said village boundary crossing Puthumurippu Kulam until its meets Uruthirapuram village boundary. Thence, towards West along the Uruthirapuram - Akkarayankulam village boundary up to Uruthirapuram Kulam thence along the centre Kalavalappu Aru towards North up to 200 meters. From that point a Hypothetical line drawn towards East. Until its meets Nivil - Uruthirapuram village boundary, thence along the said boundary crossing Paranthan - Poonagari main road, until its meets the starting point of the Northern Boundary.
