#### TOWN AND COUNTRY PLANNING ORDINANCE (CHAPTER 269)

Order under Section 6 (2) (b) and Section 21 (2) (b)

BY virtue of the powers vested in me by Section 6 (2) (*b*) and Section 21(2)(b) of the Town and Country Planning Ordinance (Chapter 269), I, Dinesh Chandra Rupasinghe Gunawardena, Minister of Urban Development and Sacred Area Development, do by this order :—

(*a*) declare that the area of land specified in the Schedule hereto shall be an Urban Development Area for the purpose of the aforesaid ordinance and shall be called the "Narahenpita Sri Abayarama Vihara Sacred Area";
