### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Johnston Xavier Fernando, Minister of Land, Land Development, Human Settlement and Ranaviru Welfare, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Seven (7) allotments of lands in total extent of about 0.0097 Hectare, depicted as Lot Nos. 9, 18, 20, 24, 25, 28 and 30 in P. P. Co 9056 of dated 17th June, 2009, prepared by the Surveyor-General, situated in the village of Rawathawatta, within the Municipal Council limits of Moratuwa, in the Divisional Secretary's Division of Moratuwa in the Colombo District and bounded as follows:

**01. Lot No. 9 – Assmt. No. 43, 3rd Lane, Dharmarathna Mawatha – Extent: 0.0001 Hectare**

North and East: Lot No. 31; South: Assmt. Nos. 30/8 and 30/8B, Charles Place; West: Lot Nos. 28 and 29.
