Declaration under Section 5

I, Johnston Xavier Fernando, Minister of Land, Land Development, Settlement and Ranaviru Welfare, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.
