**SOUTHERN PROVINCE PROVINCIAL COUNCIL**

**Notice under Section 277 of the Municipal Councils Ordinance Chapter 252 read with Section 3 of the Powers of Supervision of the Administration of Local Government Authorities Statute No. 04 of 1990 and Section 2 of the Provincial Councils (Ancillary Provisions) Act, No. 12 of 1989.**

I, Shan Wijayalal De Silva, the Minister-in-charge of the Subjects of Finance and Planning, Law and Order, Transport, Water Supply and Drainage, Electricity, Engineering Services, Health and Indigenous Medicine and Local Government of the Southern Province Provincial Council, acting under the powers vested in me under Section 277 of the Municipal Councils Ordinance Chapter 252 read with Section 2(2) of the Powers of Supervision of the Administration of Local Government Authorities Statute No. 4 of 1990 of the Southern Province Provincial Council and Section 2 of the Provincial Councils (Ancillary Provisions) Act, No. 12 of 1989, have appointed Edirimuni Samith De Silva retired Judicial Officer, to inquire into and report with regard to matters referred to under Section 277 of the Municipal Councils Ordinance and Section 2(1) of the Powers of Supervision of the Administration of Local Government Authorities Statute No. 04 of 1990 of the Southern Provincial Council, on the part of Mr. Subhawickrema Mallika Vidanachchige Upul Nishantha while functioning as mayor of Matara Municipal Council of the Matara District.

02. Further, under the powers vested in me under Section 277(1B)(i) of the Municipal Councils Ordinance Chapter 252 read with Section 3 of the Powers of Supervision of the Administration of Local Government Authorities Statute No. 04 of 1990 of the Southern Provincial Council and Section 2 of the Provincial Councils (Ancillary Provisions) Act, No. 12 of 1989, I, Shan Wijayalal de Silva, Minister-in-charge of the subjects of Finance and Planning, Law and Order, Transport, Water Supply and Drainage, Electricity, Engineering Services, Health and Indigenous Medicine and Local Government of the Southern Provincial Council Suspend with immediate effect Mr. Subhawickrema Mallika Vidanachchige Upul Nishantha, the mayor of Matara Municipal Council of the Matara District, from functioning as mayor of the said Municipal Council.

03. Further, since Mr. Subhawickrema Mallika Vidanachchige Upul Nishantha who held office as mayor of the Matara Municipal Council has been suspended from functioning in the said office with immediate effect, under Section 277 (1B)(i) of the Municipal Councils Ordinance Chapter 252 read with Section 3 of the Powers of Supervision of the Administration of Local Government Authorities Statute No. 04 of 1990 of the Southern Provincial Council and Section 2 of the Provincial Councils (Ancillary Provisions) Act, No. 12 of 1989, I order under Section 277 (1B)(i)

of the Municipal Councils Ordinance Chapter 252 read with Section 3(A)(1) of the Powers of Supervision of the Administration of Local Government Authorities Statute No. 04 of 1990 of the Southern Provincial Council and Section 2 of the Provincial Councils (Ancillary Provisions) Act, No. 12 of 1989, Mr. Deegoda Gamage Yasaratne, Deputy Mayor of the Matara Municipal Council, to exercise the powers and perform the functions of the mayor.
