**SOUTHERN PROVINCE PROVINCIAL COUNCIL**

**Notice under Section 185 of the Pradeshiya Sabha Act, No. 15 of 1987, read with Section 2(I) and Section 4 of the Powers of Supervision of the Administration of Local Government Authorities Statute No. 04 of 1990 of the Southern Provincial Council and Section 2 of the Provincial Councils (Ancillary Provisions) Act, No. 12 of 1989.**

I, Gusthinnawadu Shan Wijayalal De Silva, the Minister in-charge of the Subjects of Finance and Planning, Law and Order, Transport, Water Supply and Drainage, Electricity, Engineering Services, Health and Indigenous Medicine and Local Government of the Southern Province Provincial Council, being satisfied myself of the findings of the retired Judicial Officer who was appointed by me in terms of Section 185(2) of the Pradeshiya Sabha Act, No. 15 of 1987, read with Section 2(2) of the Powers of Supervision of the Administration of Local Government Authorities Statute No. 04 of 1990 of the Southern Provincial Council and Section 2 of the Provincial Councils (Ancillary Provisions) Act, No. 12 of 1989, to inquire into and report if Mr. Hewa Lokuge Jayasiri, the Chairman of Tissamaharama Pradeshiya Sabha, has while functioning as the Chairman of the said Pradeshiya Sabha, committed any offence falling under Section 185(I) of the Pradeshiya Sabha Act, No. 15 of 1987 and Section 2(I) of the Powers of Supervision of the Administration of Local Government Authorities Statute No. 04 of 1990 of the Southern Provincial Council, that the Chairman of Tissamaharama Pradeshiya Sabha has committed such offences as referred to under Section 2(I) of the Powers of Supervision of the Administration of Local Government Authorities Statute No. 04 of 1990 of the Southern Provincial Council and Section 185(I) of Pradeshiya Sabha Act, No. 15 of 1987, do in terms of Section 185(3)(A) of Pradeshiya Sabha Act, No. 15 of 1987 read with Section 2(I) and 4(2) of the Powers of Supervision of the Administration of Local Government Authorities Statute No. 04 of 1990 of the Southern Provincial Council and Section 2 of the Provincial Councils (Ancillary Provisions) Act, No. 12 of 1989, hereby remove Mr. Hewa Lokuge Jayasiri, the Chairman of Tissamaharama Pradeshiya Sabha from the Office of Chairman and Membership of Tissamaharama Pradeshiya Sabha.
