#### FILLING OF A VACANCY IN THE OFFICE OF DEPUTY MAYOR OF THE KURUNEGALA MUNICIPAL COUNCIL UNDER SECTION 65A(1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

**FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE KALMUNAI MUNICIPAL COUNCIL  
UNDER SECTION 65A(2) OF THE LOCAL AUTHORITIES ELECTIONS  
ORDINANCE (CHAPTER 262)**
