Depreciation Table for the Valuation of Used Motor Vehicles

REFERENCE the Order made by the Hon. Minister of Finance, in terms of Article 10 of Schedule E of the Customs (Amendments) Act, No. 02 of 2003, and published in *Gazette Notification*, No. 1273/21 of 31st January, 2003, the public is hereby informed that the following depreciation table shall apply with effect from 01.06.2010 for used motor vehicles classifiable within HS Headings given below.

Depreciation table published in *Gazette Notification*, No. 1362/15 of 14th October, 2004 is hereby rescinded.

Period between the date of first registration and the date of shipment (date of Bill of Lading) of the relevant vehicle shall be taken for the computation of the period of use.

In the case where only the month and year is given as the first registration the last date of the relevant month shall be taken as the date of first registration.

In the case where only the year is given as the first registration 01st July of the relevant year shall be taken as the date of first registration.
