##### FILLING OF A VACANCY IN THE OFFICE OF CHAIRMAN OF THE PALLEPOLA PRADESHIYA SABHA UNDER SECTION 65A(1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of Chairman in Pallepola Pradeshiya Sabha has fallen vacant by reason of being ceased to be a member of the party ;
