#### URBAN COUNCILS ORDINANCE

#### Order

BY virtue of the powers vested in me by section 2, 3, 5 and 9 of the Urban Council Ordinance (Chapter 255), I, A. L. M. Athaullah, Minister of Local Government and Provincial Councils, do by this Order–

- (1) declare the area specified in the Schedule hereto, to be a town for the purpose of that Ordinance;
- (2) define the administrative limits of that town to be the limits as set out in that Schedule;
- (3) constitute an Urban Council for the town declared under paragraph (1) of this Order and assign the following name and designation to such council:—

#### The area of land consisting of the following Grama Niladari Divisions:

By a line drawn from the last mentioned point westwards along the low water mark of the lagoon up to the point where it meets Nainaveli paddy field lane;
