Members of the Public are hereby informed that, I have decided to commence after 23rd March 2011, the Certification process of this application as per the established procedures to examine the degree of applicant's compliance with the applicable Air Navigation Regulations, International Standards and Recommended Practices specified by ICAO and associated local requirements adopted by this office and ascertain their level of competence for the safe, secure, efficient operation of proposed air services, prior to granting them the requisite Air Operator Certificate, Airline License, Charter License and Aerial Work License together with other relevant approvals for the commencement of proposed operations.

Any person may not less than Ten (10) days before the aforementioned date in the penultimate paragraph, make representations to me in writing, setting out the specific grounds on which such representations are made in respect of this application, in accordance with the Air Navigation Regulations, such representation shall accompany written evidence as to the truth of any statement contained therein, A copy of every such representation shall be sent by the person making it to the applicant, at the same time as it is sent to me and a certificate to that effect shall be attached to the representation.
