NORTH-WESTERN PROVINCIAL AGRICULTURAL DEVELOPMENT STATUTE No...... OF 2011 OF THE NORTH-WESTERN PROVINCE PROVINCIAL COUNCIL

This statute is established in order to create provisions for planning, implementing and directing relevant Introduction subject's assigned to provincial councils as indicated in No.9 of list of Schedule 9 of the 13th Amendment of the Democratic Socialist Republic of Sri Lanka for achieving the agricultural policies and objective that are being proposed to implement for a stable development in agriculture in the northwestern province and other agriculture related matters.

North-Western Province Provincial Council doth hereby impose as follows:-

- 1. This statute is referred to as North-Western Provincial Agriculture Development Statute No.... of 2011 of the north western province. It shall be come in to effect from the date of its approval by the Governor of the North-Western Province.

#### SECTION 2

#### Composition and responsibilities of the Provincial Agricultural Department

10.	0. The North Western Provincial Agriculture Department hereinafter referred to as the "Department" shall implement the provisions of this statute.	
11.	1. With the Consent to provincial Minister of Agriculture the North-Western Provincial Governor shall appoint a Class 1 officer of the Sri Lanka Agricultural Service with the title of "North Western Provincial Director of Agriculture" for the implementation of the provisions of statute.

#### SECTION 3

#### Provincial Agricultural Committee

- 19. The Provincial Agriculture Committee hereinafter called as "Committee "shall establish to easy implementation of the Provincial Agriculture policy Minister of Provincial Agriculture should be the Chairman of this committee and Secretary of the Agriculture Ministry should be the secretary of this committee. The committee maintained jointly with the Provincial Animal Production and Development Committee.
- 20. This Committee should consist of following members.
  - 1. Members of the Advisory Committee of Agriculture Ministry;
  - 2. District Secretaries of Puttalam and Kurunegala Districts ;
  - 3. Provincial Director of Agriculture North-Western Province;

- 21. Member from 20.1 to 20.25 are appointed by appointing by committee members virtue official and 20.26 to 20.30 are appointed by the discretion of the minister
- 22. The Accession period of the members appointed accession period of member by the minister is two years
- 23. Vacancy of member ship may be occur due to completion of the appointed by the minister Resignation of the post, dismiss by the minister with is discretion and the minister should fill these Vacancies
- 24. The Committee should meet at least two months .Additional meeting can be called by the Secretary with the advice of the Chairman if necessary .
  - 25. (1) The Quorum of this committee should be 4/1 of the Members .
    - (2) No barrier to make decisions by the committee if there is any vacant position of the member
  - 26. The committee should prepare require procedure to held committee meetings.
  - 27. Task of the Provincial Agriculture Committee
    - (1) Present and Implement Suggestions and approvals to prepare Policies relating to National Policies and statute.
    - (2) Provide advices to Monitor and Implement tasks mentioned in the Statute.
    - (3) Approval of Provincial Agriculture Plan.
    - (4) Follow up and Evaluate Provincial Agriculture Plan providing Resources and Assistance to implement the plan.
    - (5) Provide necessary decisions when problem occur Implementing and Preparing Provincial Agriculture Policy in the Province.
    - (6) Grant approval before start any task by the Institute, Organization, Foundation, Forum, Project, Program or any other concurrent Institute, Individual or Team of Individual relating to Provincial Agriculture Expansion, Promotion, Education, Agriculture Services and Provincial Agriculture Researches.
    - (7) Cultivate Agricultural Lands to get maximum profits, Restrict who done non agricultural activities in the agricultural lands and activate rights of "Anda" Farmers.

#### SECTION 4

#### Agriculture Product Development Organization

- 28. Agriculture development Volunteer Organizations can be established hereinafter called as "Organization" combining farmers who cultivate under advices of the Minister, Secretary and the Director and such all organizations should register under this department.
- 29. This Organization should be activate as Agriculture Development Organization Title
- 30. Department should prepare common Statute for these Organizations and Implement from the date approved by the Minister. Administrative and Financial Powers are vested in the Minister
- 31 These Organizations should activate to cultivate any crop or fulfill Agriculture Development Activities.

- 32 Provincial, Zonal and Divisional Organizations can be established by these Organizations and Statute of their content, activities and common Provisions should prepared by the Department. Approval of the Provincial Committee is necessary for this purpose.
- 33. They can use Government and Non Government project funds to develop their funds.

Liquidate and Cancel the Registration

#### SECTION 5

#### GENERAL PROVISIONS

- 34. Any Institution, Organization, Foundation, Group Obtaining approval for Programe or any such similar Institution or Indi-agricultural matters Vidsal's or group of Individuals shall obtain Approval from the provincial Agricultural committee Prior to the implementation of any pertaining to agricultural expension, promotion, education on agriculture, providing agricultural service or conducting re-searches on the province.
- 35. All orders issued by the minister as indicated in paragraph 7 about, should be published in the *Gazette* and any such Order should be come into force from the dead indicated in The Order
- 36. All orders main by the Minister should be submitted for the Approval for the provincial Council after the *Gazette* Notification All orders which were not approval by the Provincial Councils should be separated with out prejudice To any previous activities implementation and should be Published in the *Gazette*
- 37. Any person who breach, neglects or will fully obstruct any Order or provision of this Statute or any order made under the Statute shall be an offender under this statute
- 38. The Provincial Director or any person assigned by him shall have the authority to file legal action against any offender who violates this statute

#### SECTION 6

#### INTERPRETATION

In this Statute unless the context otherwise requires

Interpretation "Provincial Council" means North Western Provincial Council

"Governor" means Governor of the North Western Provincial Council

- "Minister" means Secretary of the Agriculture Ministry of the North-Western Province
- "Secretary" means Secretary of the Agriculture Ministry of the North Western Province
- "Department" means department of Agriculture North Western Province

"Director" means Director of Agriculture North-Western Province

"Agriculture" means Cultivation and Protection of crops (other than Plantation crops and *Gazette* as Export Development Crops) with or without commercial purposes to ensure food and nutritional secure of the people

"Agriculture Promotion" means development of agricultural resources to a maximum level

- "Agriculture Expansion" means mediate to provide resources, assists to implement and introduce new technological methods within farmers and other interested groups to uplift food production and development, crop production, and coir production
- "Agriculture Education" means Implement, Assist and Introduce new technological methods to farmers and other interested groups to uplift crop production to prepare foods and coir products and provide knowledge and develop abilities and attitudes of farmers and other interested groups.
- "Agricultural Services" means provide required material or non material and live or non live infrastructure facilities to reach expected Agriculture expansion and development aims of the province
- "Provincial base Agriculture Research" means Agriculture researches done by the provincial level (not for build up basic theories) to solve technical problems and related problems and getting approval for introduced technical relevance's
- "Agriculture Committee" means Agriculture Committee of the North Western Province
- "Agriculture Production Society" mean collective farmers organizations based on agriculture production promoting aims
- "Farmer Organization Committee" means units combine with the farmer's organizations and production societies
