##### THE LAND REFORM LAW No. 1 OF 1972

##### Order under subsection (4) of Section 27A

BY virtue of the powers vested in me by subsection (4) of section 27A of the Land Reform Law, No.1 of 1972 as amended by the Land Reform (Special Provisions) Act, No. 39 of 1981, read with paragraph (2) of Article 44 of the Constitution of the Democratic Socialist Republic of Sri Lanka, I, Mahinda Rajapaksa, President, do hereby –

- (a) amend the Order made under subsection (2) of section 27A of the aforesaid Act, and published in Gazette Extraordinary No. 815/10 of April 21, 1994 relating to the land called and known as Bentota *alias* Bentota Watta morefully described in the First Schedule to this Order and which had vested in the Sri Lanka State Plantations Corporation established by the Sri Lanka State Plantations Corporation Act, No. 4 of 1958, by revoking on grounds of non-compliance with such terms and conditions relating to consideration for the vesting in such Corporation, such portion of the said Order as relates to the extent of land called Atakohata Watta specified in the Second Schedule hereto which is part of the land called and known as Bentota *alias* Bentota Watta;
- (b) state that upon revocation, such extent of land shall re-vest in the Land Reform Commission;
