##### **STATUTE TO PROVIDE DOMESTIC AND MOBILE TELEPHONE FACILITIES PERTAINING TO OFFICIAL DUTIES TO THE MEMBERS OF PRADESHIYA SABHA OF THE WESTERN PROVINCE No. 10 of 2010**

A Statute to make provisions to provide domestic and Mobile telephone facilities for official duties to Members of Pradeshiya Sabha of the Western Province.

Be it enacted as follows by the Western Province Provincial Council of the Democratic Socialist Republic of Sri Lanka :-

1. This statute is cited as Statute to Provide Domestic and Mobile Telephone Facilities Pertaining to official Duties to the Members of Pradeshiya Sabha of the Western Province, No. 10 of 2010 and it shall be effected from January 01st of the Calendar year followed by the date on which the signature of the Governor is placed.

Objectives and  
Tasks.

2. It is legal to bear expenditure from the Pradeshiya Sabha Fund. by a Pradeshiya Sabha, for the provision of residential and mobile telephone facilities for the official duties of the Members elected to the Pradeshiya Sabha and maintenance of them.
3. Maximum expenditure limits in lieu of the settlement of residential and mobile telephone bills for official duties of the Members of Pradeshiya Sabha shall be the amounts regulated by the rules enacted under this statute by the Minister.
4. The Minister can formulate rules with regard to the tasks mentioned in this statute.
5. (i) The rules composed by the Minister shall be published in the *Gazette* paper and subsequent to publishing thus ; they shall be referred to the Provincial Council for approval as immediately as possible.  
  
(ii) Subsequent to receiving the approval by the Provincial Council regarding every rule composed by the Minister, it shall be published through a *Gazette* Paper whereas, that approved notification shall be enacted from the date it is published in the *Gazette* paper,

Definition.

6. Unless other meaning is required regarding words, in this statute, the "Minister in charge of the subject of Local Government of the Western Province" is meant by the Word "Minister".
