### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Tennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

The boundaries and Extent of all that Land surveyed by the Survey Superintendent of the Puttalam District in the Advance Tracing Plan No. Pu/Kal/2010/511 of 14th March, 2011, shown as Lot 'A' to 'F' extent of 0.1021 Hectares situated within the village of Sinnakudiruppuwa is Minor Division of Kalpity and Mampuri in Kalpitiya Divisional Secretariat of Puttalam District in North Western Province are as below:

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Tennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below in the 1st Paragraph is needed for a public purpose and will be acquired under the provisions of that Act. It describe in the 2nd Paragraph from which land that the servitude will be acquired,

1. Acquisition of servitude of the land for the construction and maintenance of Treated Water Transmission Main of Ginigathhena Water Supply Scheme of Nuwara Eliya District Group Water Supply Project.

2. Two allotments of the land in total extent of about 0.1711 Hectare, depicted as Lot "D" and "H" in Advance Tracing No. NU/AMB/2010/35 dated on 24.05.2010, prepared by the Surveyor General situated in the Village called Kadawala, in Ambagamuwa Korale Minor Division in the Divisional Secretary's Division of Ambagamuwa Korale in Nuwara Eliya District, Central Province and bounded as follows:
