**NORTH WESTERN PROVINCE PROVINCIAL COUNCIL**

**Inquiry conducted under Section 185 of Pradeshiya Sabha Act, No. 15 of 1987 to be read with  
Section 2 of Provincial Council (Incidental Provisions) Act, No. 12 of 1989**

IN terms of the powers vested in me under Provisions stated in section 185 of Pradeshiya Sabha Act, No. 15 of 1987 to be read with section 2 of Provincial Council (Incidental Provisions) Act, No. 12 of 1989, I, Hettiachchi Mudiyansele Athula Sarath Kumara Wijesingha, Chief Minister of the North Western Province and Minister of the Subject of Local Government do hereby appoint Retired High Court Judge, O. W. O. B. Weerasena esquire as a Single Person Commission of Inquiry to inquire into whether the offences mentioned in section 185 were committed by the Chairman Senanayake Mudiyansele Bandula Pushpakumara Senanayake, while holding his office as the Chairman of Pradeshiya Sabha, Maho on the following grounds / allegations in terms of section 185 and a report may be submitted within a period of 03 months.

**Allegations to be inquired into**

*ALLEGATIONS :-*

- (i) During his tenure of office as Chairman of the Pradeshiya Sabha, Maho from on or about 01st of April, 2011 has committed the offence/offences stated in section/sections 185 (1) (a) and / or 185 (1) (b) and / or 185 (1) (e) of Pradeshiya Sabha Act, No. 15 of 1987, by taking measures to Pay a sum of Rupees Fourty Six Thousand two Hundred and Seventy Five (Rs. 46,275.00) or and amount close to that amount by the payment voucher No. 624 to the institute of "Sesath Electricles Company", No. 68, Maliban Street, Colombo 11 from the General Fund without a formal resolution by the Pradeshiya Sabha on or about 2011.06.23 for the supply of street lamp accessories for the repair of Street Lamps within the area of authority Pradeshiya Sabha, Maho.
- (ii) During his tenure of office as Chairman of the Pradeshiya Sabha Maho from on or about 01st of April, 2011 has committed the offence/offences stated in section/sections 185 (1) (a) and / or 185 (1) (b) and / or 185 (1) (e) of Pradeshiya Sabha Act, No. 15 of 1987, by disturbing to the duty of Acting Secretary, Management Assistant Mrs. I. M. Swarnathilaka of Pradeshiya Sabha Maho on 26.07.2011.

- (iii) During his tenure of office as Chairman of the Pradeshiya Sabha, Maho from on or about 01st of April, 2011, has committed the offence/offences stated in section/sections 185 (1) (a) and / or 185 (1) (b) and / or 185 (1) (e) of Pradeshiya Sabha Act, No. 15 of 1987, by ordering Acting Secretary, Management Assistant Mrs. I. M. Swarnathilaka of Pradeshiya Sabha, Maho to make payment from the General fund of the Pradeshiya Sabha without fulfilling the prerequisites in respect of a financial matter under section 219(1) of the Pradeshiya Sabha Act No. 15 of 1987 of Pradeshiya Sabha on or about 26.07.2006.
- (iv) During his tenure of office as Chairman of the Pradeshiya Sabha, Maho from on or about 01st of April, 2011 has committed the offences stated in sections and / or 185 (1) (b) and / or 185 (1) (e) of Pradeshiya Sabha Act, No. 15 of 1987, by obtaining 27 sand cubes from the Magistrate Court, Maho by submitting written facts to the Magistrate Court Maho, that it was for the construction of Phase II and Phase III of the Bus Stand Maho of the Pradeshiya Sabha Maho and using it for his personnel matter.
- (v) During his tenure of office as Chairman of the Pradeshiya Sabha Maho from on or about 01st of April, 2011 has committed the offence/offences stated in section/sections 185 (1) (a) and / or 185 (1) (b) and / or 185 (1) (e) of Pradeshiya Sabha Act, No. 15 of 1987, by violating the section 174 of Pradeshiya Sabha Act No. 15 of 1987 by taking measures to pay a sum of (Rs.1,43,850/-) or an amount close to that amount to the institute of “Sesath Electrical Company”, No. 68, Meliban Street, Colombo 11, without observing a formal tender procedure on or about 2011.07.13 for the supply of Street Lamp accessories for the repair of Street lamps within the area of authority of Pradeshiya Sabha Maho.
- (vi) During his tenure of office as Chairman of the Pradeshiya Sabha Maho from on or about 01st of April, 2011 has committed the offence/offences stated in section/sections 185 (1) (a) and / or 185 (1) (b) and / or 185 (1) (e) of Pradeshiya Sabha Act, No. 15 of 1987, by taking measures to pay sum of (Rs. 1,43,850.00) or an amount close to that amount by the payment vouchers No. 741, 742, 743 and 744 to the institute of “Sesath Electrical Company”, No. 68, Maliban Street, Colombo 11 from the General Fund without a formal resolution by the Pradeshiya Sabha on or about 2011.06.13 for the supply of street lamp accessories for the repair of Street Lamps within the area of authority Pradeshiya Sabha, Maho.

Further this retired high court Judge Oliver Weerasena esquire is entitled to the powers of a Commissioner appointed under commission of inquiry Act in terms of the provisions more fully described in section 185 of Pradeshiya Sabha Act, No. 15 of 1987 to be read with section 2 of Provincial Council (incidental Provisions) Act, No. 12 of 1987 and you are further informed to conduct this inquiry and submit a report including the findings of the inquiry within a period of 3 months from the date of this appointment.
